Call to Order and Approval of Minutes

Ms. Nicole McCann, Chair, called to order the meeting of the Maryland Medicaid Advisory Committee (MMAC) at 1:00 p.m. Committee members approved the minutes from the June 23, 2022, meeting as written. Ms. Lori Doyle attended the meeting for Ms. Shannon Hall. Ms. McCann introduced two new members: Delegate Ariana Kelly who replaces Delegate Peña-Melnyk and Stephanie Scharpf, from Jai Medical Systems, is the new MCO representative.

Departmental Report and COVID-19 Updates

Ms. Tricia Roddy, Deputy Medicaid Director, provided the Committee with a combined Departmental report and COVID-19 update.

The federal public health emergency (PHE) has been extended once again through October 13, 2022. Everyone is fully anticipating that it will be extended once more time through the end of the calendar year. This means we will continue to receive the enhanced federal match of 6.2 percent through the end of CY 2022. If the Department of Health and Human Services (HHS) were to discontinue the PHE on October 13, 2022, they would have to provide notice to the states by August 14, 2022. They have committed to giving states a 60-day notice prior to ending the PHE.

Medicaid enrollment continues to increase with a current total of 1,723,568 (see attached chart). Because we are receiving the 6.2 percent federal match, we cannot disenroll anyone and the maintenance of effort will continue, and reenrollments will begin starting January 1, 2023. We are still seeing week over week growth of a few thousand people. We do expect these numbers to continue to increase incrementally since the federal PHE unwinding has not begun.

The Department is working on several new benefit and eligibility expansions that the legislature and Governor placed in the budget. Some of those new programs include Mobile Crisis and Crisis Stabilization Services. We have hired Health Management Associates to help us implement those two services. We are also implementing Peer Recovery Specialists through our substance use providers. We are anticipate implementing that service in April 2023. We are also implementing adult dental benefits that will start January 1, 2023. The Department will also be implementing the new coverage group of pregnant non-citizens through the unborn child. There is a lot of work to be done at the federal and state level to implement this program. We are working closely with CMS on all of the federal requirements. With all of the work involved in implementing this program, we anticipate this program will be implemented in July 2023.

Telehealth Update

Ms. Nicole Majewski and Mr. David Sharp from Maryland Health Care Commission (MHCC) gave the Committee an overview of the Telehealth Study (see attached presentation).

Program of All-Inclusive Care for the Elderly (PACE)

Ms. Laura Goodman, Deputy Director, Office of Innovation, Research and Development, gave the Committee an update on the expansion of the PACE program (see attached presentation).

Waiver, State Plan and Regulation Changes

Ms. Alison Donley, Medicaid Provider Services, gave the Committee a status update on waivers, regulations, and state plan amendment changes (see attached charts).

Public Comments

Ms. Stephanie Klapper, Maryland Health Care for All! Coalition gave public comments on the implementation of the Healthy Babies Equity Act.
