



## **Monkeypox Vaccine and Vaccine Administration Fee Schedule**

The American Medical Association (AMA) has announced new vaccine-specific Current Procedural Terminology (CPT®) codes to report immunizations for the monkeypox and smallpox virus. The Federal government is currently sponsoring the vaccine ingredient. In response, the Medicaid fee-for-service (FFS) program is reimbursing for the administration of the vaccine. The following fee schedule is a summary of the codes, their descriptions, their effective dates, and the FFS reimbursement rate.

**NOTE:** Institutional providers should bill for vaccine and vaccine administration on a professional claim to receive reimbursement.

## Monkeypox and Smallpox Vaccine Fee Schedule

The program will provide reimbursement for vaccine administration when the federal government covers the ingredient cost. The reimbursement will be the higher of

- (1) The VFC administration rate or
- (2) 100% of the CMS-designated vaccine administration code for that vaccine.

Do **not** bill vaccine administration codes 90460-90474, when billing for the administration of vaccines that are provided at no charge by the Federal Government, please **use the specific vaccine ingredient code and -SE modifier in Block 24D.**
