Subject: Update to Fiscal Year 2023 Rates for Brain Injury Waiver Services

Effective July 1, 2022, the Maryland Medical Assistance Program provided an emergency one-time rate increase of 11.25% to all Brain Injury providers for the first quarter of Fiscal Year 2023 (July 1, 2022 through September 30, 2022). That rate increase included an emergency, temporary four percent increase authorized by the American Rescue Plan Act.

Effective October 1, 2022, the emergency temporary one-time four percent rate increase will no longer be applied toward brain injury services. As of this date, the rate increase will be 7.25%, applied to the rates in place effective November 1, 2021 as referenced in [Provider Transmittal 18-22 \(Waiver for Adults with Brain Injury Transmittal No. 6\)](#) for the remaining three quarters of Fiscal Year 2023 (October 1, 2022 through June 30, 2023).

These rates are inclusive of the statutory rate increase for Fiscal Year 2023 pursuant to Senate Bill 290 Fiscal Year 2023 Budget (2022) and the Governor's supplemental budget. Providers may bill the new rates for services provided on or after October 1, 2022.
