NOTE: Please ensure that the appropriate staff members in your organization are informed of the content of this transmittal.

On January 7, 2015, the Governor proposed and the Board of Public Works approved a 50 percent reduction in the 2.5 percent budgeted rate increase for Maryland Medicaid's Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) nursing services. As a result of this decision, the Medicaid rate for EPSDT nursing services provided on or after January 1, 2015 is increased by 1.25 percent.

Attached is a chart of the revised fee schedule for the remainder of Fiscal Year 2015. Providers may bill the new rates for services provided on or after January 1, 2015.
