

RE: Adjustment to Fiscal Year 2014 Program Rates

On July 1, 2013, payment rates for certain services under the Waiver for Older Adults Program will increase. Rates will increase by 2.5 percent based on the Medical Assistance Program's budget for Fiscal Year 2014.
