The Maryland Department of Health is pleased to announce the release of a solicitation titled **REM Case Manager Provider Solicitation**, which may be found at:

Interested parties should go to the above website and download the specifications for the above titled Solicitation Proposal. The Department intends to make one award to a single Offeror whose Proposal is deemed the most advantageous to the State.

Offerors must meet the following minimum requirements:

- 1. At least five (5) years of experience providing healthcare case management services for adults and children with complex medical needs.
- 2. Free from conflicts of interest:
  - i. As defined in the solicitation; or
  - ii. Neither the Offeror, nor the parents, affiliates, nor subsidiaries of the Offeror, may provide any direct health care services other than case management under the Maryland Medicaid program.
- 3. Capable of communicating in other languages and providing interpreter services for all languages.
- 4. Commit in writing to being available beyond the termination of the Contract for the accountability of any services performed as part of the Contract including, but not limited to, providing documents and witnesses.
- 5. At least five (5) years experience working with Medicaid programs, including

MCOs.

The contract resulting from this Solicitation shall be for the period beginning on or around:

## March 1, 2025 through February 28, 2028 with two additional option years.
