Re: Fiscal Year 2023 Rates for Autism Waiver Services

Note: **Please ensure that appropriate staff members in your organization are informed of the contents of this transmittal.**

Effective July 1, 2022, the Maryland Medical Assistance Program will increase the rates for certain program services rendered to Medicaid participants under Code of Maryland Regulations (COMAR) 10.09.56 by 12 percent (*see enclosed fee schedules*). This rate increase is inclusive of the statutory rate increase for Fiscal Year 2023 based on amounts allocated by the Maryland State Department of Education and an additional increase pursuant to Senate Bill 290, Fiscal Year 2023 Budget and the Governor's supplemental budget. This rate increase also includes a temporary four percent increase authorized by the American Rescue Plan Act, which will be applied to certain home and community-based services for Fiscal Year 2023 only.

Attached is a list of revised rates for Fiscal Year 2023. Providers may bill the new rates for services provided on or after July 1, 2022.
