RE: Fiscal Year 2021 Rates for Nursing Services

NOTE: Please ensure the appropriate staff members in your organization are informed of the contents of this transmittal.

Effective January 1, 2021 the Maryland Medical Assistance Program will increase the reimbursement rates for nursing services rendered to Medicaid participants under COMAR 10.09.53, 10.09.27 and 10.09.69. Rates will increase by 4 percent based on the Medical Assistance Program's budget for Fiscal Year 2021. Attached is a chart of the revised fee schedule. Providers may bill the new rates for services provided on or after January 1, 2021.
