Attestation of CDC-Recognized Organization Record Keeping

- The organization's records will include an attestation from the CDC-recognized organization, as applicable, that the Medicaid participant for whom it is submitting a claim to the Managed Care Organization (MCO), has met the eligibility criteria, attendance, and weight loss measures described in the Maryland Medicaid HealthChoice DPP eligibility criteria and reimbursement methodology.

Attestation of Fingerprint Criminal Background Check Completion

- The organization understands that all owners with 5% or more direct or indirect ownership interest will be required to complete a Fingerprint Criminal Background Check (FCBC) as required by the Centers for Medicare and Medicaid Services (CMS).

Attestation of an Enrollment Site Visit Conducted by Another State Medicaid Agency [Out of state organizations only, choose one]
