I am having trouble getting the waiver services my child needs. What can I do?

Autism and Developmental Disabilities Waivers Talk to your child's service/resource coordinator or call the HealthChoice Enrollee Action Line at 1-800-284-4510 to file a complaint or appeal.

Model Waiver Talk to your child's case manager or call 410-767-1448 to file a complaint or appeal. You have a right to appeal denials, reductions, or delays in getting benefits or services.

Who do I call for help getting non-waiver health services my child needs?

- If your child is in HealthChoice, call your child's health plan customer service number or the HealthChoice Enrollee Action Line at 1-800-284-4510 to file a complaint.
- If your child is in HealthChoice and you want to file an appeal, call the HealthChoice Enrollee Action Line at 1-800-284-4510. See the HealthChoice brochure on Help for Special Health Care Needs.
- If your child is in Fee-for-Service call 1-800-492-5231 to file a complaint or appeal. See the Fee-for-Service brochure on Help for Special Health Care Needs.
- You are entitled to a fair hearing to settle the dispute. You have a right to get legal help for the fair hearing. Call 1-800-233-7201.

My child has private insurance too. How does this work with the Waiver Programs?

Try to identify a provider who accepts both your private insurance plan and Medical Assistance/Medicaid. Your child's health provider must bill the private insurance plan first. If your private insurance does not cover a service your child needs, then your child's health provider may bill Medicaid. Make sure your provider knows that you receive Medical Assistance/Medicaid or MCHP because your private insurance co-pay may be covered.

Waiver Programs

Waiver Programs offer services to certain populations in the community as alternatives to institutionalization. Participants in the waiver programs must meet an institutional level of care. Maryland has three Waiver programs that serve children.

- Autism Waiver
- Developmental Disabilities (DD) Waiver
- Model Waiver

The Autism Waiver and the Model Waiver primarily serve children. The DD Waiver serves adults and children.

The Waiver Programs are different from Medical Assistance/ Medicaid and MCHP.

- Waivers have different medical and financial eligibility rules that do not take the parents' income and assets into consideration
- Waivers have some additional services
- A limited number of children can be in Waivers

The Autism Waiver is for children with certain Autism Spectrum Disorders who:

- Are between 1 year old and the end of the school year in which the youth turns 21 years old; and
- Have an Individualized Family Service Plan (IFSP) or Individualized Education Program (IEP).

Children are enrolled in HealthChoice health plans, also called MCOs. See the HealthChoice brochure.

The Developmental Disabilities Waiver is for children with:

• Mental retardation or other developmental disabilities.

Children are enrolled in HealthChoice health plans.

The Model Waiver is for children with complex medical needs who:

- Complete the enrollment process prior to age 22; and
- Have a certain level of medical need.

Children receive services through Fee-for-Service. See the Fee-for-Service brochure.
