- Re: 72-hour emergency supply of non-formulary, non-preferred medications or medications requiring prior authorization; Prior authorization and other telephone contact information; National provider Identification Number (NPI); Verification of eligibility; and Tamper-resistant prescription pads.

The purpose of this transmittal is to remind providers that in emergency situations all Maryland Medical Assistance recipients are entitled to receive a 72-hour supply of medicine while awaiting prior authorization or approval to dispense a non-formulary or non-preferred medication. This transmittal also provides important telephone contact information and information regarding the Preferred Drug List (PDL), NPI numbers, verification of eligibility, and tamper-resistant prescription pads.

Emergency Supplies/Prior Authorization

In emergency situations, all Maryland Medicaid HealthChoice managed care organizations (MCOs) and the Maryland Medicaid fee-for-service program will cover a minimum 72-hour supply of drugs. These emergency supplies are to be provided while the pharmacist is awaiting prior authorization or approval to dispense a non-formulary or non-preferred medication. Pharmacists should use their professional judgment in determining whether the prescription is needed on an emergency basis.

Please note the fee-for-service Medicaid Program will allow a pharmacist to dispense a 72-hour supply of a Schedule II controlled substance, but the pharmacist must keep the prescription and therefore the member must return to the doctor to get a new prescription in order to get the full supply of drugs. MCOs may have similar limitations to prevent abuse of these drugs.

National Provider Identification (NPI) Numbers

Until further notice pharmacies will continue using the physician DEA (not the physician NPI number) when submitting pharmacy claims to indicate the identification of the prescriber. Further notice will be issued when use of the physician NPI number on submitted pharmacy claims becomes mandatory. HealthChoice MCOs will notify pharmacies and prescribers directly of their NPI requirements. If you do not already have an NPI, go online to <u>https://nppes.cms.hhs.gov</u> to apply for one.

Verification of Eligibility

Eligibility for any type of Maryland Medicaid recipient can be verified by calling the Eligibility Verification System (EVS) at 1-866-710-1447. EVS operates 24 hours a day, seven days a week. The same information is available on the web at <u>www.emdhealthchoice.org</u>. Access requires your MA provider number and a password. There is a MCO transfer option on the EVS. If the recipient is a member of an MCO, the provider can press "3" and the call will be transferred directly to the MCO's call center to verify primary care physician (PCP) assignment. For a recipient in a facility, the provider will be given the name and phone number of the facility. If you need to hear a verification a second time, press "1" and the information will be repeated. Press "2" in order to enter the next recipient's information. If a mistake is made prior to pressing "#," you can press "*" to go back and enter the information correctly. Past eligibility can now be obtained by entering the recipient's Social Security number, and date of service.

Tamper-Resistant Prescription Pads

DHMH issued General Provider Transmittal No. 63 on August 31, 2007, informing prescribers and providers of the new requirements concerning tamper-resistant prescriptions. Due to federal legislation recently passed and signed, the new requirements which were to be applicable effective October 1, 2007, will now be effective April 1, 2008. Prior to approval of the extension, the federal government provided further clarification on issues related to the tamper-resistant prescription requirements, which can be found in a frequently asked questions document on the Centers for Medicare & Medicaid Services website at
