On July 1, 2017, payment for providers of services in the Community First Choice and Community Personal Assistance Services programs will increase. Rates will increase by 2 percent based on the Medical Assistance Program's budget for Fiscal Year 2018.

Attached are revised rates for Fiscal Year 2018. Providers may bill the new rates for services provided on or after July 1, 2017. Please note that rates for Personal Emergency Response Systems Installation and Monitoring are not subject to the annual increase in accordance with COMAR 10.09.84.24.
