**SUBJECT:** New Utilization Control Agent

Effective February 1, 2011, Delmarva Foundation for Medical Care, Inc. (Delmarva) will replace the Keystone Peer Review Organization, Inc. (KePRO) as the Maryland Medical Assistance Program's contractor for utilization control services. On that date, Delmarva will assume responsibility for performing utilization review activities formerly conducted by KePRO for the following Medicaid Program areas:

- Acute Hospitals – Preadmission reviews for elective and emergency admissions; preoperative day reviews; preauthorization of procedures; concurrent reviews; and retrospective reviews
- Chronic/Special Hospitals and Nursing Facilities – Medical Eligibility Reviews; onsite Continued Stay Reviews; and patient assessments, PASRR compliance, and medical review for liens for nursing facilities

- Medical Day Care Waiver, Waiver for Older Adults, Living at Home Waiver, Model Waiver, Traumatic Brain Injury (TBI) Waiver, and Program of All-Inclusive Care for the Elderly (PACE) – Medical Eligibility Reviews (initial and annual recertification); Medical Day Care service reviews

Delmarva will continue to utilize MEDecision's iEXCHANGE™ for receiving and processing 3808 and Medical Eligibility Review requests. Providers will retain the same user name and password for iEXCHANGE™. Please note, however, that starting February 1, providers must access iEXCHANGE™ using a new link that can be found at <http://dhmh.dfmc.org>. This link will also contain information on iEXCHANGE™ training. Additional information on the acute care review process will be sent to all hospitals in a separate transmittal.

PLEASE NOTE THAT THE FINAL DATE TO SUBMIT REQUESTS FOR MEDICAL ELIGIBILITY, PREAUTHORIZATIONS, CONCURRENT AND RETROSPECTIVE REVIEWS TO **KEPRO** IS FRIDAY, JANUARY 28, 2011. ANY REQUEST THAT IS NOT SUBMITTED BY JANUARY 28 MUST BE HELD UNTIL FEBRUARY 1, THEN SUBMITTED TO **DELMARVA** ON OR AFTER THAT DATE. Requests submitted by January 28 that are complete, i.e., contain sufficient information to make a determination, will be processed and a decision issued by KePRO. If a request is incomplete or does not have sufficient information with which to make a determination, KePRO will forward the request to Delmarva and will notify the provider that Delmarva will be handling the case.

The Program is confident that review services will continue with a minimum of disruption to providers, and that any problems will be promptly resolved.
