Maryland Medicaid Prescriber Enrollment & Pharmacy Claim Processing Requirement (UPDATE)

According to Federal Regulations, prescribing providers must be actively enrolled with the Maryland Medicaid Program for the program to reimburse for services, including prescription claims.

Section 6401 of the Affordable Care Act and Code of Federal Regulations section 42 CFR § 455.410(b) require that ordering, referring, and prescribing (ORP) providers be enrolled with the state Medicaid Program. To comply, Medicaid must deny any pharmacy claim where a prescriber is not actively enrolled.

This is an update to previously communicated <u>Advisory No. 255</u>. **Starting July 1, 2024**, all pharmacy claims, including those for behavioral health medications, for any Maryland Medicaid Fee-for-Service (FFS) participant for medications where the prescriber submitted on the claim is not enrolled in Maryland Medicaid, will be denied with the following message: **"NCPDP Edit 25 M/I Prescriber Identification"** in the response transaction. For those claims, pharmacies that are able to view the long message in the response transaction will notice the following message:

"UNENROLLED PRESCRIBER. STARTING 7/1/24 CLAIM WILL DENY UNLESS THE PRESCRIBER ENROLLS WITH MARYLAND MEDICAID VIA EPREP. FOR MORE INFO DIRECT PRESCRIBER TO http://bit.ly/3TKORP"

In an effort to give timely notice to the pharmacy community concerning important pharmacy topics, the Maryland Department of Health (MDH) Office of Pharmacy Services (OPS) has developed the Maryland Medicaid Pharmacy Program Advisory.
