



Coverage for Over The Counter (OTC) Pharmacy Products

Maryland Medicaid Pharmacy Program will cover the following federally rebatable OTC products when a participant presents a prescription written by an authorized prescriber:
(All other OTCs will deny with NCPDP 70 – NDC not covered)

Antihistamines, decongestant, minimally sedating (Alavert Allergy Sinus, Allergy Relief D-12 &24 Hour, Claritin D 12 &24Hr, loratadine D 24 hour)
Antihistamines, minimally sedating (Alavert, Allergy Relief, Claritin 10 Reditabs, Tavist ND, and loratadine tablets)
