Minimum Data Set Focused Surveys

The Office of Health Care Quality's nursing home surveyors will begin conducting Minimum Data Set (MDS) Focused surveys this federal fiscal year. This year, these surveys will be conducted in a limited number of facilities. Surveys will focus on compliance with MDS and nurse staffing requirements, (F272 - F287, F353 – F356).

The focused surveys **will not** be conducted during a standard recertification survey. However, these surveys may be done immediately before or after a complaint survey. In these cases, each survey will be completed and documented separately.

Deficiencies identified during the MDS Focused surveys will result in relevant citations and enforcement actions in accordance with normal and existing CMS policy and regulations. In the event that additional care concerns (beyond the MDS and staffing foci of this focused survey) are identified during on-site reviews, those concerns will be investigated during the survey or, if immediate investigation is not possible, be entered as a complaint for review during another visit.

In order to facilitate this survey process, I have attached a copy of the MDS Focused survey worksheet #1 that will be given to facility staff upon initiation of a focused survey. It is expected that the form will be completed in one hour. The faster a facility provides this information to the surveyors, the faster the survey team can begin conducting their reviews and complete the survey. It is estimated that most surveys will take two days.
