#### **March 12, 2012**

A CORRECTED MDS 3.0 RAI Manual (v1.08) Errata document, "MDS 3.0 RAI Manual (v1.08) V3 Errata\_March\_12\_2012" has been posted under the download section of this page. ### Change in MDS Correction Policy

Effective with submissions on April 1, 2011, CMS will no longer allow facilities to modify the MDS 3.0 reason for assessment items, assessment reference date (ARD) discharge date and entry date. If a modification record is submitted attempting to change any of these items, the record will be rejected. These MDA items must be corrected by inactivating the old record and submitting a new record. Please refer to Chapter Five in the RAI Manual as revised to reflect this change.
