

Samples Collected


- Sample Collection began in October 2021 and is continuing
- As of 1/16/2024 2,406 samples have been tested.
- 17 of the 25 SSPs in Maryland collect samples.
 - Covering 12 jurisdictions

RAD Sampling by Jurisdiction over Time





Samples Containing Cocaine


- 40% of samples tested contained cocaine.
- In CY23 Q4 (October December) there were a total of 110 samples that contained cocaine.
- 12.8% increase from the previous quarter (CY23 Q3)
- 16% increase in samples containing cocaine from same time last year (CY22 Q4)





Samples Containing Xylazine


- 32.2% of samples tested contained Xylazine.
- In CY23 Q4 (October December) there were a total of 39 samples that contained Xylazine.
- 18.7% decrease from the previous quarter (CY23 Q3)
- 18% decrease in samples containing xylazine from same time last year (CY22 Q4)





Samples Containing Fentanyl & Fentanyl Analogs


- 45.7% of samples tested contained fentanyl.
- In CY23 Q4 (October December) there were a total of 50 samples that contained fentanyl.
- 26.3% decrease from the previous quarter (CY23 Q3)
- 28.9% decrease in samples containing fentanyl from same time last year (CY22 Q4)





Samples Containing Other Opioids


- 0.8% of samples tested contained other opioids.
- In CY23 Q4 (October December) there were no samples that contained other opioids.
- 0.9% decrease from the previous quarter (CY23 Q3)
- 3.2% decrease in samples containing other opioids from same time last year (CY22 Q4)





Samples Containing Amphetamines


- 6.4% of samples tested contained amphetamines.
- In CY23 Q4 (October December) there were a total of 31 samples that contained Amphetamines.
- 2.9% increase from the previous quarter (CY23 Q3)
- 9.1% increase in samples containing amphetamines from same time last year (CY22 Q4)





Samples Containing Heroin & Related Compounds

- 1% of samples tested contained heroin.
- In CY23 Q4 (October December) there were a total of 2 samples that contained heroin.
- 0.6% increase from the previous quarter (CY23 Q3)
- 0.9% decrease in samples containing heroin from same time last year (CY22 Q4)
