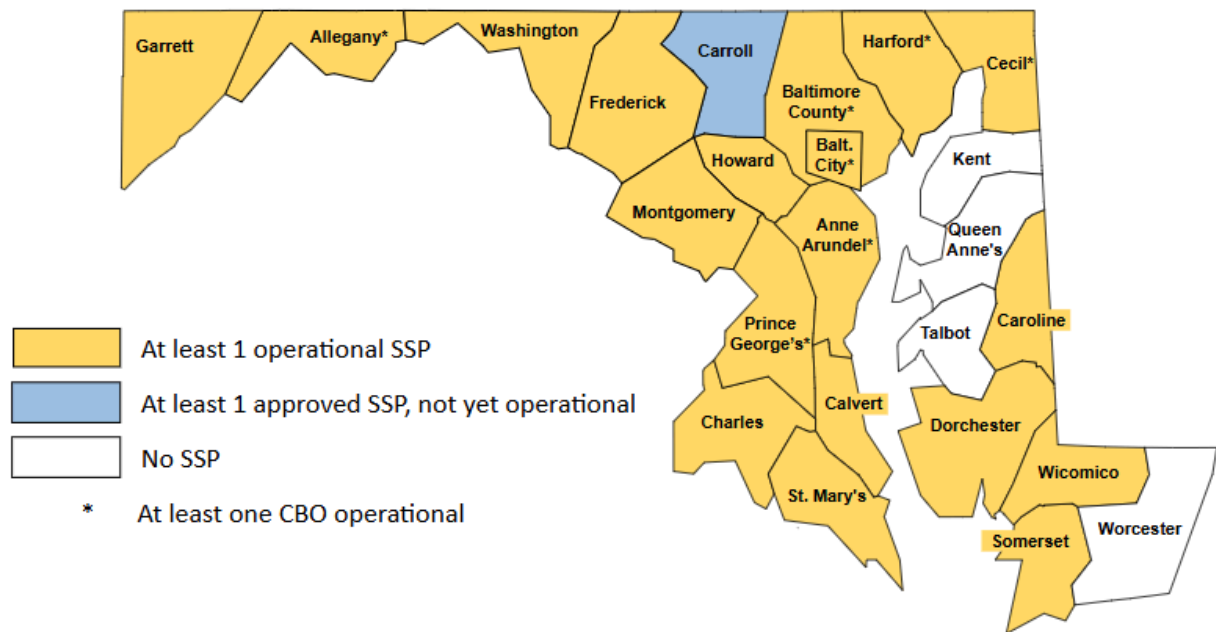




SYRINGE SERVICE PROGRAMS IN MARYLAND

 RAD Samples are collected at this SSP.

Maryland’s Rapid Analysis of Drugs (RAD) program is a statewide drug checking program that allows SSP participants to voluntarily submit used paraphernalia for drug composition testing. Sample results are provided back to SSP participants through SSP staff. All testing is confidential - no personal information is required. 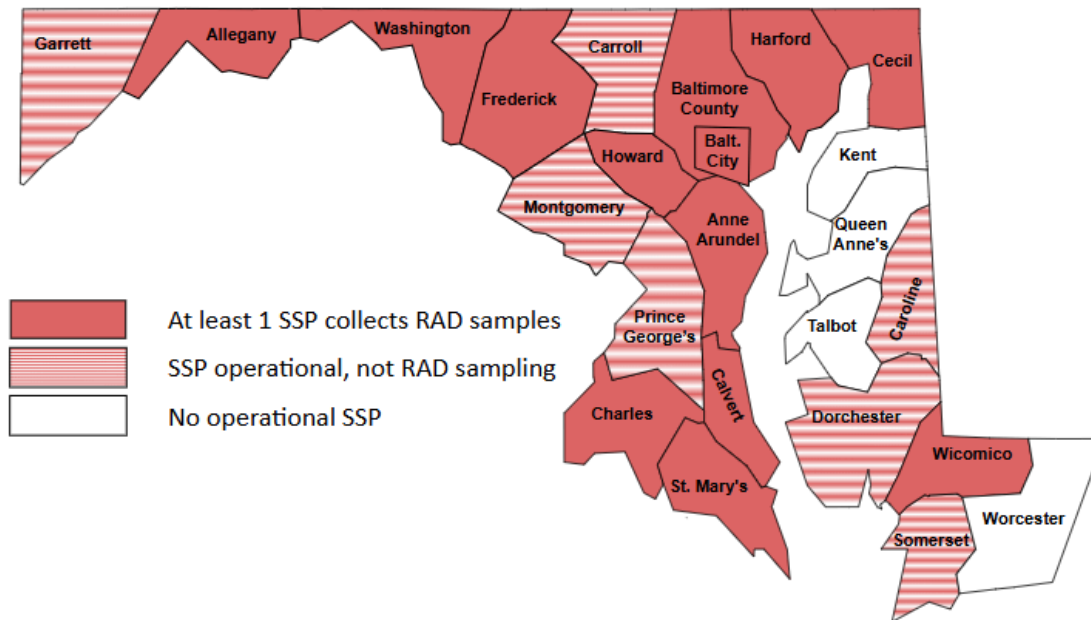
 Hep C and MOUD Telehealth Visits through JHU are conducted at this SSP.

Maryland’s ACCESS Telehealth program is implemented at SSPs in partnership with Johns Hopkins University School of Medicine, Viral Hepatitis Center. The telehealth program provides access to medication for opioid use disorder (MOUD) and Hepatitis C treatment using telemedicine technology on site at their local SSP. 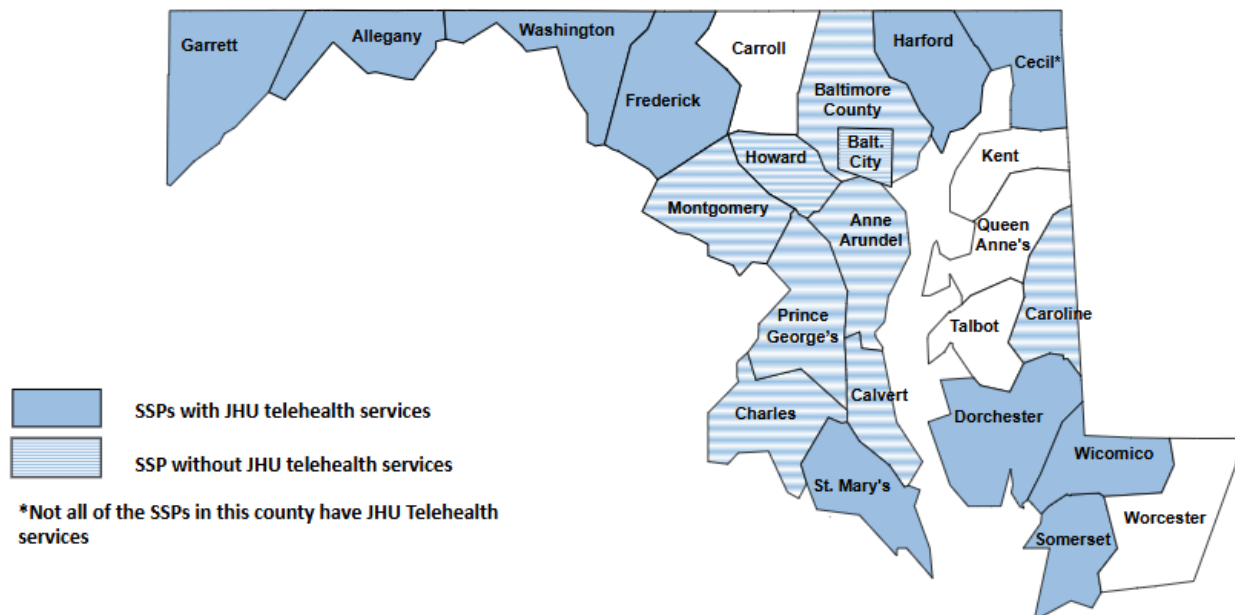

Immunity from Prosecution for SSP Affiliates: MD Health-Gen Code [§ 24-908](#) (2016)

- (a) Immunity from prosecution. A program staff member, Program volunteer, or Program participant may not be arrested, charged, or prosecuted for violating [§ 5-601](#), [§5-619](#), [§ 5-620](#), or [§ 5-902](#)(c) or (d) of the Criminal Law Article for possessing or distributing controlled paraphernalia or drug paraphernalia whenever the possession or distribution of the controlled paraphernalia or drug paraphernalia is a direct result of the employee's, volunteer's, or participant's activities in connection with the work of a Program authorized under this subtitle.
