**ORDER TERMINATING SUSPENSION OF REGISTRATION  
FOR DELINQUENT CHILD SUPPORT**

On September 19, 2016, the Maryland Board of Pharmacy (the “Board”) issued an Order of Suspension of Registration for Delinquent Child Support (“Order of Suspension”) against Alea Nichole Citro, Pharmacy Technician, Registration No. T09437 (the “Respondent”). The Board suspended the Respondent’s registration to practice as a pharmacy technician in Maryland due to her delinquent child support payments upon a request from the Baltimore County Office of the Child Support Enforcement Administration of the Maryland Department of Human Resources (the “Administration”), pursuant to Md. Code Ann., Fam. Law § 10-119.3(e)(2)(i) (2012 Repl. Vol.).


On or about July 13, 2018, the Board received a Notice to Reinstate the Respondent’s registration from the Administration. However, the Respondent’s registration was revoked by the Board pursuant to a public disciplinary order issued on April 18, 2018; as such, the Board cannot reinstate her registration.

Therefore, pursuant to Md. Code Ann., Fam. Law § 10-119.3(k), on this 26th day of July, 2018, by the Maryland Board of Pharmacy, it is hereby:

**ORDERED** that the suspension for delinquent child support of the registration to practice as a pharmacy technician in Maryland held by Alea Nichole Citro, Registration No. T09437, is **LIFTED**; and it is further,

**ORDERED** that the revocation of the registration to practice as a pharmacy technician in Maryland held by Alea Nichole Citro, Registration No. T09437, pursuant to the Final Order of Revocation issued by the Board on April 18, 2018, remains in full force and effect; and it is further,

**ORDERED** that this is a Final Order of the Maryland Board of Pharmacy and, as such, is a public document pursuant to Md. Code Ann., Gen. Provisions §4-333(b).
