# PRE-CHARGE CONSENT ORDER

## **Background**

The Maryland Board of Pharmacy (the "Board") received a self-report from Getinge USA Sales, LLC, ("Getinge") of a Summary Order issued by the Kansas Board of Pharmacy for distributing products into Kansas without a Kansas distributor's registration. The Board subsequently opened an investigation and received documents indicating that Getinge had distributed prescription medical devices into Maryland prior to the issuance of its Maryland wholesale distributor's permit.

In lieu of instituting formal proceedings against Getinge in accordance with the Maryland Pharmacy Act, Md. Code Ann., Health Occ. § 12-101 et seq., the Board and Getinge have agreed to resolve this matter as set forth in this Pre-Charge Consent Order.

### **FINDINGS OF FACT**

- Getinge USA Sales, LLC, is a wholesale drug distributor located and licensed in Wayne, New Jersey.
- 2. On or about January 31, 2022, Getinge self-reported to the Board a Summary Order issued by the Kansas Board of Pharmacy, dated December 9, 2021. The Summary Order was based upon findings by the Kansas Board of Pharmacy that Getinge distributed prescription products into Kansas without a Kansas wholesale distributor's registration.

- Upon receiving the self-report from Getinge, the Board opened an investigation into the matter.
- 4. Getinge cooperated with the Board's investigation and provided requested documents. The Board's investigation determined that Getinge distributed certain prescription devices into Maryland prior to obtaining a Maryland wholesale distributor's permit.
- 5. Getinge provided requested copies of shipping records for products shipped into Maryland. Specifically, between January 1, 2020, and September 24, 2021, Getinge reported shipping prescription medical devices into Maryland without a Maryland wholesale distributor's permit.
- Wholesale distributors must hold a permit issued by the Board before the wholesale distributor engages in the wholesale distribution of prescription drugs or prescription devices into Maryland.
- Getinge obtained a Maryland wholesale distributor's permit on September 24,
   2021, which permit remains active and in good standing to date.

# CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, the Board concludes that Getinge USA Sales, LLC, is subject to a sanction in accordance with Md. Code Ann., Health Occ. §§ 12-6C-03 and 12-6C-11.

ORDERED that Getinge USA Sales, LLC, shall pay a FINE in the amount of FIVE THOUSAND DOLLARS (\$5,000.00), payable to the Maryland Board of Pharmacy within thirty (30) days of the date of this Order, and mailed to:

ORDERED that in the event that Getinge violates any of the terms above, the Board, after notice and an opportunity for a hearing, and a determination of a violation, may impose any sanction it deems appropriate, including the imposition of further fines in accordance with Health Occ. § 12-6C-11; and be it further,

ORDERED that this is a formal order and as such is a public document pursuant to the Maryland Public Information Act, Md. Code Ann., General Provisions Article § 4-101, et seq.
