**CONSENT ORDER FOR INITIAL REGISTRATION**

**BACKGROUND**

On or about May 30, 2023, Vilma Iglesias applied to the Maryland State Board of Pharmacy (the “Board”) for registration as a pharmacy technician. On her application, Ms. Iglesias answered “yes” to a personal attestation question regarding having a criminal history and provided a detailed explanation. Ms. Iglesias also submitted to a Maryland Criminal Justice Information System (“CJIS”) background check in accordance with Md. Code Ann., Health Occ. § 12-6B-02(c), which revealed the same criminal history she disclosed.

In lieu of instituting formal proceedings against Ms. Iglesias’s application, in accordance with the Maryland Pharmacy Act, Md. Code Ann., Health Occ. § 12-6B-01 *et seq.*, the Board offered Ms. Iglesias the opportunity to resolve this matter by agreeing to the terms set forth in this Consent Order.

**FINDINGS OF FACT**

1. On or about May 30, 2023, Ms. Iglesias applied to the Board for registration as a pharmacy technician.
2. On her application, Ms. Iglesias answered “yes” to the question “Have you committed a criminal act for which you pled guilty or nolo contendere, or for which

you were convicted or received probation before judgment?” Ms. Iglesias provided a detailed explanation of her “yes” answer.

3. Specifically, Ms. Iglesias stated that she was arrested for and charged with child abuse related to an incident of domestic abuse which occurred in May 2020. A psychiatric evaluation performed at the time confirmed that Ms. Iglesias had been a victim of abuse.
4. Eventually, Ms. Iglesias pled guilty to one count of conspiracy to commit first-degree child abuse and was sentenced to time served and five years of supervised probation. As a term of her probation, Ms. Iglesias was released to a rehabilitative housing program for women and children, many of whom suffered trauma and abuse.
5. Due to support and encouragement received from her housing program, Ms. Iglesias decide to pursue her pharmacy technician training program, at which she excelled. Ms. Iglesias believes employment as a pharmacy technician will significantly help her overcome her history of trauma.

### CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, the Board concludes that Ms. Iglesias is subject to discipline pursuant to Md. Code Ann., Health Occ. §§ 12-6B-02(b)(1) & 12-6B-09(22).

### ORDER

Based on an affirmative vote of the Board, it is this 17<sup>th</sup> day of January, 2024, hereby:

**ORDERED** that Ms. Iglesias be GRANTED a pharmacy technician registration, provided she is otherwise eligible for a registration; and be it further,

**ORDERED** that for the first year of registration, Ms. Iglesias shall ensure that her pharmacy employer provide quarterly employer reports to the Board; and be it further,


**ORDERED** that in the event Ms. Iglesias's pharmacy employer reports issues with her employment in its quarterly reports, the Board may impose further disciplinary action against Ms. Iglesias's registration, including suspension or revocation, after notice and an opportunity for a hearing; and be it further,

**ORDERED** that Ms. Iglesias shall be responsible for all costs associated with this Consent Order; and be it further,

**ORDERED** that this is a formal order of the Maryland Board of Pharmacy and as such is a public document pursuant to the Md. Code Ann., Gen. Provisions § 4-333(b).


