CONSENT ORDER FOR INITIAL REGISTRATION

BACKGROUND

On or about February 15, 2023, Chelsie-Marie Johnson applied to the Maryland State Board of Pharmacy (the “Board”) for registration as a pharmacy technician. On her application, Ms. Johnson answered “yes” to a personal attestation question regarding having a criminal history. Ms. Johnson also submitted to a Maryland Criminal Justice Information System (“CJIS”) background check in accordance with Md. Code Ann., Health Occ. § 12-6B-02(c).

In lieu of instituting formal proceedings against Ms. Johnson’s application, in accordance with the Maryland Pharmacy Act, Md. Code Ann., Health Occ. § 12-6B-01 *et seq.*, the Board offered Ms. Johnson the opportunity to resolve this matter by agreeing to the terms set forth in this Consent Order.

FINDINGS OF FACT

1. On or about February 15, 2023, Ms. Johnson applied to the Board for registration as a pharmacy technician.
2. On her application, Ms. Johnson answered “yes” to the question “Have you committed an offense involving alcohol or controlled substances to which you pled guilty or nolo contendere, or for which you were convicted or received probation

before judgment?” Ms. Johnson did not provide any additional information related to her “yes” answer.

3. Upon the Board’s request for further information, Ms. Johnson stated that she was convicted of driving under the influence in May 2022, for which she received probation before judgment and had to complete a six-month alcohol course. Ms. Johnson also stated that she was arrested for driving under the influence in November 2022 and that the court case was still pending.
4. A review of the State’s online case judiciary database indicates that Ms. Johnson was convicted of driving under the influence for the November 2022 incident and received two years of supervised probation on April 14, 2023.

CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, the Board concludes that Ms. Johnson is subject to discipline pursuant to Md. Code Ann., Health Occ. §§ 12-6B-02(b)(1) & 12-6B-09(22).

ORDER

Based on an affirmative vote of the Board, it is this th13 day of June, 2023, hereby:

ORDERED that Ms. Johnson be GRANTED a pharmacy technician registration; and be it further,

ORDERED that upon the first renewal of her pharmacy technician registration, Ms. Johnson shall submit to a State criminal history records check; and be it further,


ORDERED that in the event Ms. Johnson’s criminal history records check indicates further criminal activity, the Board may impose further disciplinary action against

Ms. Johnson's registration, including suspension or revocation, after notice and an opportunity for a hearing; and be it further,

ORDERED that Ms. Johnson shall be responsible for all costs associated with this Consent Order; and be it further,

ORDERED that this is a formal order of the Maryland Board of Pharmacy and as such is a public document pursuant to Md. Code Ann., Gen. Provisions § 4-333(b).
