FINAL CONSENT ORDER

The State Board of Pharmacy ("the Board") charged Charles Chigozie Mbachu (the "Respondent"), registration number: T20290, with violating certain provisions of the Maryland Pharmacy Act, ("the Act") Md. Code Ann., Health Occ. ("Health. Occ.") §§12-101 et seq. (2014 Repl. Vol. & 2018 Supp.). The pertinent provisions of the Act state:

Health. Occ. §12-6B-09.

Subject to the hearing provision of § 12–315 of this title, the Board may deny a pharmacy technician's registration to any applicant, reprimand a registered pharmacy technician, place any pharmacy technician's registration on probation, or suspend or revoke a pharmacy technician's registration if the applicant or pharmacy technician registrant:

- (25) Violates any regulation adopted by the Board;
- (27) Participates in any activity that is grounds for Board action under § 12–313 or § 12–409 of this title[.]

Health. Occ. §12-313.

- (b) Subject to the hearing provisions of § 12–315 of this subtitle, the Board, on the affirmative vote of a majority of its members then serving, may deny a license to any applicant for a pharmacist's license, reprimand any licensee, place any licensee on probation, or suspend or revoke a license of a pharmacist if the applicant or licensee:
- (27) Violates any regulation adopted by the Board[.]

The Board also charges the Respondent with violating:

Code of Md. Regs 10.34.10

- .01 Patient Safety and Welfare.
- B. A pharmacist may not:
- (3) Engage in unprofessional conduct.

FINDINGS OF FACT

The Board finds that:

- 1. At all times relevant hereto, the Respondent was registered to practice as a pharmacy technician in the State of Maryland.
- 2. The Respondent was originally registered to practice as a pharmacy technician in Maryland on or about November 7, 2017.
 - 3. The Respondent's registration expires on January 31, 2019.
- 4. At all times relevant hereto, Pharmacy A employees notified the Board that the Respondent worked as a pharmacy technician at a pharmacy ("Pharmacy A"), a national retail chain, located in Maryland.¹
- 5. In or around April 12, 2017, Pharmacy A notified the Board that the Respondent was terminated from Pharmacy A after an investigation conducted by Pharmacy A employees.
- 6. The investigation conducted by Pharmacy A's investigation revealed that the Respondent stole controlled substances and other medications while he was employed at Pharmacy A.

- 7. An investigation conducted by Pharmacy A staff revealed that Vyvanse tablets, a controlled substance was pilfered from the pharmacy.
- 8. The Respondent cooperated with Pharmacy's A's investigation and returned the medication to the pharmacy.
- 9. The Respondent's conduct as set forth above is a violation of Health Occ.§12-6B-09 (25) and (27); Health Occ.§12-313 (b) 313 (27); and/or Code of Md. Regs 10.34.10 .01B (3).

CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, the Board concludes that the Respondent violated H.O. § 12-6B- 09 (3) and (27), H.O § 12-313(b) (25), and Code Md. Regs.10.34.10.01B (3).

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, it is this 7th day of June 2019, a majority of the quorum of the Board, hereby

ORDERED that the Respondent's registration to practice as a pharmacy technician in the State of Maryland is hereby **SUSPENDED** for a period of one (1) year; and it is further

ORDERED that during the period of the Respondent's suspension, the Respondent shall be evaluated by the Board's rehabilitation program at the University of Maryland, and follow any recommendations may by the evaluators; and it is further

ORDERED that Respondent shall return to the Board all Maryland pharmacy all technician registrations within ten (10) days of the date of this Order; and it is further.

ORDERED that the effective date of this Order is the date that it is signed by the Board; and it is further

ORDERED that this Order is final and a public document pursuant to Md. Code Ann., General Provisions §§ 4-101 *et seq.* (2014 Repl. Vol and 2018 Supp.).

ORDERED that this document constitutes a formal disciplinary action of the Board of Pharmacy and is a public document for purposes of public disclosure, pursuant to Md. Code Ann., General Provisions §§ 4-101 *et seq.* (2014 Repl. Vol and 2018 Supp.).
