CONSENT ORDER

Background

The Maryland Board of Pharmacy (the “Board”) received notice from the pharmacy employer of Mitchell McKinney, R.Ph. (the “Respondent”), that the Respondent had been disciplined by the Louisiana Board of Pharmacy as a result of failing to report disciplinary action imposed by the Kentucky Board of Pharmacy for continuing education violations.

In lieu of instituting formal proceedings against the Respondent, in accordance with the Maryland Pharmacy Act, Md. Code Ann., Health Occ. § 12-101 *et seq.*, the Board and Respondent, have agreed to resolve this matter as set forth in this Consent Order.

FINDINGS OF FACT

1. On or about November 4, 2013, the Respondent was originally issued a license to practice pharmacy in Maryland. The Respondent’s license is active and will expire on October 31, 2016.
2. The Respondent is designated by a non-resident pharmacy permit holder located in New Jersey, as the Maryland licensed pharmacist on staff, in accordance with Md. Code Ann., Health Occ. Art. § 12-403(e).
3. On February 24, 2016, the Louisiana Board of Pharmacy entered into a Consent

Box 2051, Baltimore, MD 21203-2051 (*Please reference the case number, 16-099, on your check or money order to ensure proper assignment to your case.*); and be it further,

ORDERED that Respondent, shall ensure compliance with all laws and regulations governing the practice of pharmacy in Maryland; and be it further,

ORDERED that in the event that Respondent violates any of the terms above, the Board, after notice and an opportunity for a hearing, and a determination of a violation, may impose any further disciplinary sanction it deems appropriate, including probation, suspension or revocation, or civil monetary penalties, said violation being proven by a preponderance of the evidence; and be it further,

ORDERED that this is a formal order and as such is a public document pursuant to Md. Code Ann., General Provisions Article § 4-333.
