SUPPLEMENTAL ORDER –
Lifting Suspension and Imposing Probation

Background

The Maryland Board of Pharmacy (the “Board”) is in receipt of a petition from Sun Park, License No. 10586, requesting to lift the suspension of her license in accordance with a Consent Order, dated April 22, 2024. The Board originally issued an Order for Summary Suspension of Ms. Park’s pharmacist’s license on October 20, 2023, based on diversion of a controlled dangerous substance. Subsequently, the Board issued a Consent Order suspending Ms. Park’s license for one (1) year, effective October 20, 2023, and stated that she may petition to lift the suspension provided that she fully complied with certain terms relating to rehabilitation and monitoring by the Board’s rehabilitation committee, Pharmacist Rehabilitation Services (“PRS”). Ms. Park has submitted evidence of her compliance with her PRS contract, and PRS has submitted documented support of her petition. Therefore, the Board voted to lift the suspension and place Ms. Park’s license on immediate probation with terms as set forth below.

ORDER

Based on an affirmative vote of the Board, it is this 9th day of December,
2024, hereby,

ORDERED that the suspension of Ms. Park’s pharmacist license, License Number

10586, is LIFTED; and be it further,

ORDERED that Ms. Park's license be placed on immediate PROBATION for at least TWO (2) YEARS; and be it further,

ORDERED that during the probationary period, Ms. Park:

(1) May not practice pharmacy as a "floater" pharmacist;

(2) Shall continue her rehabilitation contract with the Pharmacists Rehabilitation Services ("PRS") committee;

(3) Shall abstain from the use of controlled dangerous drugs, drugs with abuse potential, and all other mood-altering substances unless PRS is provided sufficient written documentation from Ms. Park's healthcare provider regarding medical necessity;

(4) Shall submit to random testing of hair samples for prohibited substances at least quarterly;

(5) Shall continue with a professional support group and counseling, at a frequency determined by PRS;

(6) Shall comply with all other treatment and monitoring conditions imposed as part of the PRS contract and this Order; and

(7) Shall execute any and all releases necessary to allow PRS and the Board to access medical and SUD treatment information for purposes of monitoring and enforcement of this Order and the PRS contract; and be it further,

ORDERED that all hair sample testing submitted under this Order shall be:

(1) Submitted within 24 hours of the PRS staff's notification to submit a sample; and

(2) Submitted at a CLIA-certified laboratory; and be it further,

ORDERED that Ms. Park shall ensure that her pharmacist supervisor submits to the

Board quarterly reports, utilizing the Board's form regarding of her professional performance; and be it further,

ORDERED that after one (1) year of probation, Ms. Park may petition the Board to modify her probationary terms provided that she has fully complied with the terms of probation and does not have any pending complaints filed against her; and be it further,

ORDERED that after two (2) years of probation, Ms. Park may petition to terminate probation provided that she has fully complied with the probationary terms and has no pending complaints against her; and be it further,

ORDERED that Ms. Park shall at all times cooperate with the Board in the monitoring, supervision, and investigation of her compliance with the terms and conditions of this Order; and be it further,

ORDERED that Ms. Park's failure to fully cooperate with the Board or PRS shall be deemed a violation of the terms of probation and a violation of this Order; and be it further,

ORDERED that in the event the Board finds for any good faith reason that Ms. Park has violated any of the conditions of suspension herein, or in the event that the Board finds for any good faith reason that Ms. Park has committed a violation of Title 12 of the Health Occupations Article or regulations adopted thereunder, the Board may take further disciplinary action against Ms. Park's license provided that she is given notice and an opportunity for a hearing, or issue a summary suspension if appropriate; and be it further,


ORDERED that Ms. Park shall bear the expenses associated with this Order; and be it further,

ORDERED that this document constitutes a formal disciplinary action of the Maryland State Board of Pharmacy and is therefore a public document for purposes of public disclosure,

pursuant to the Public Information Act, General Provisions Art. § 4-333, and shall be posted and reported in accordance with State and federal laws.
