**ORDER OF REINSTATEMENT**

**Background**

On September 15, 2005, Mr. Proctor submitted a Petition to lift the suspension of his license to practice pharmacy. Mr. Proctor's license to practice pharmacy was suspended for two (2) years with all but 18 months stayed, pursuant to a Consent Order dated April 21, 2004. The Consent Order was based upon the Board's finding that Mr. Proctor was convicted in the U.S. District Court for the Eastern District of Virginia (Criminal Case No. 03-97-A) for filing a false statement and representation on his application for federal employment as a pharmacist. This federal conviction constituted a felony and a crime of moral turpitude, and thus Mr. Proctor was disciplined by the Board of Pharmacy for his violation of Md. Code Ann., Health Occ. § 12-313(b)(21). The April 21, 2004, Consent Order required that Mr. Proctor successfully complete:

- a. a Board-approved college level (2-3 credits) ethics course;
- b. a Board-approved college level (2-3 credits) course on medication errors and patient safety; and
- c. continuing education credit requirements set forth in Code Md. Regs. tit. 10, § 34.18.

The Consent Order further provides that upon lifting of the suspension, Mr. Proctor's license shall be placed on probation with probationary terms to be determined by the Board.

**FINDINGS OF FACT**

1. Mr. Proctor has fully complied with the terms of suspension set forth above and has submitted to the Board proof of completion of all coursework.

2. Mr. Proctor has satisfactorily served his 18-month suspension period and has timely submitted a petition to lift the suspension of his license.

**ORDER**

Based on an affirmative vote of the Board, it is this 16 day of JANUARY, 2006,  
hereby:

**ORDERED** that the SUSPENSION of Mr. Proctor's license to practice pharmacy is hereby LIFTED; and be it further,

**ORDERED** that Mr. Proctor's license shall be placed on PROBATION for a minimum of TWO (2) YEARS, commencing on October 19, 2005, during which time Mr. Proctor shall:


1. Ensure that Mr. Proctor's pharmacist supervisor submit quarterly progress reports to the Board; and
2. Provide a copy of this Order to prospective pharmacy employers and ensure that the employer complete the attached Employer Verification form and return it to the Board prior to commencement of any pharmacy employment; and be it further,

**ORDERED** that after two (2) years of probation, Mr. Proctor may petition the Board for termination of his probationary status without any conditions or restrictions whatsoever. If Mr. Proctor has satisfactorily complied with all conditions of probation and there are no outstanding complaints regarding Mr. Proctor, the Board shall terminate the probation; and be it further,

**ORDERED** that if Mr. Proctor violates any of the terms or conditions of this Order, then the Board, after a determination of the violation and notice, and an opportunity for a hearing, may impose any other disciplinary sanctions it deems appropriate, including suspension or revocation, said violation being proven by a preponderance of the evidence; and be it further,

**ORDERED** that this is a final order of the Maryland Board of Pharmacy and as such is a public document pursuant to the Maryland Annotated Code, State Government Article, Section 10-617(h).
