**ORDER LIFTING SUSPENSION AND  
IMPOSING PROBATION**

**Background**

The Maryland Board of Pharmacy (the “Board”) is in receipt of a petition from Lisa White, License No. 12969, requesting to lift the suspension of her license as set forth in a Consent Order In Lieu of Continuing Summary Suspension, dated October 9, 2018. The Order provides that Ms. White may petition to lift the suspension after August 13, 2019, provided that she has fully complied with certain terms. Ms. White and the Board’s designated rehabilitation committee, Pharmacy Rehabilitation Services, have submitted evidence of her compliance and cooperation with the terms of the above Consent Order. Therefore, the Board has voted to lift the suspension and place Ms. White’s license on immediate probation with terms and conditions as set forth below.

**ORDER**

Based on an affirmative vote of the Board, it is this 6<sup>th</sup> day of November, 2020, hereby,

**ORDERED** that the suspension of Ms. White’s license is LIFTED; and be it further,

**ORDERED** that Ms. White’s license be placed on immediate PROBATION for at least THREE (3) YEARS; and be it further,

**ORDERED** that during the probationary period, Ms. White shall continue and remain in

full compliance with her monitoring contract with the Pharmacy Rehabilitation Services (“PRS”), which contract shall, at minimum, require Ms. White to:

- (1) Submit to random urine screenings at a frequency established by PRS;
- (2) Attend NA/AA meetings at least 3 times per week and submit proof of attendance to PRS;
- (3) Ensure that her pharmacist supervisor submits quarterly employee performance reports to PRS; and be it further,

**ORDERED** that PRS shall submit a progress report to the Board at least monthly regarding Ms. White’s compliance; and be it further,

**ORDERED** that all urine screens submitted under this Order shall be:

- (1) Submitted at a CLIA-certified laboratory;
- (2) Negative for any controlled dangerous substance, narcotics, cocaine, or other mood-altering substances or drugs with abuse potential, except as provided below; and be it further,

**ORDERED** that Ms. White shall abstain from the ingestion of controlled dangerous substances, narcotics, cocaine, or other mood-altering substances or drugs with abuse potential, except that Ms. White may only ingest such substances as prescribed for legitimate medical reasons under the following conditions:

- (1) Ms. White must be a bona fide patient of a licensed Maryland prescriber who is aware of this Order;
- (2) The medication must be lawfully prescribed by Ms. White’s physician or other authorized medical practitioner;
- (3) Ms. White must provide PRS, in writing, within seventy-two (72) hours of receiving the medication: (a) the name and address of the prescriber; (b) the illness or

medical condition diagnosed; (c) the type, strength, amount and dosage of the medication; (d) and a signed statement consenting to the release of all medical information about Ms. White from the prescriber to the Board and PRS; and be it further,

**ORDERED** that Ms. White's execution of this Order shall constitute a release of any and all medical records, substance abuse treatment records, and psychological/psychiatric records pertaining to Ms. White to the Board and PRS in complying with the terms and conditions set forth herein. Further, Ms. White agrees and consents to the release by the Board and PRS of any information or data produced in relation to this Order to any treatment provider; and be it further,

**ORDERED** that after one (1) year of probation, Ms. White may petition the Board to modify her probationary terms provided that she has fully complied with the terms of probation and does not have any pending complaints filed against her; and be it further,

**ORDERED** that after three (3) years of probation, Ms. White may petition to terminate the probation provided that she has fully complied with the probationary terms and has no pending complaints against her; and be it further,

**ORDERED** that Ms. White shall at all times cooperate with the Board and PRS in the monitoring, supervision, and investigation of her compliance with the terms and conditions of this Order; and be it further,

**ORDERED** that Ms. White shall provide the Board with written notification in advance of any period of time during which she may be unreachable due to travel or other reason; and be it further,

**ORDERED** that Ms. White's failure to fully cooperate with the Board or PRS shall be deemed a violation of the terms of probation and a violation of this Order; and be it further,

**ORDERED** that in the event the Board finds for any good faith reason that Ms. White

has violated any of the conditions of probation herein, or in the event that the Board finds for any good faith reason that Ms. White has committed a violation of Title 12 of the Health Occupations Article or regulations adopted thereunder, or has relapsed, the Board may immediately summarily suspend Ms. White's license prior to a hearing, provided that Ms. White is given the opportunity for a show cause hearing within a reasonable time of such action; and be it further,

**ORDERED** that Ms. White shall bear the expenses associated with this Order; and be it further,

**ORDERED** that this document constitutes a formal disciplinary action of the Maryland Board of Pharmacy and is therefore a public document for purposes of public disclosure, pursuant to the Public Information Act., General Provisions Art., § 4-333.
