ORDER OF MODIFICATION

The Maryland Board of Pharmacy (the "Board") is in receipt of a petition from Lisa White, License No. 12969, requesting modification of the terms of probation set forth in the Supplemental Order Lifting Suspension, dated January 5, 2011 (the "Supplemental Order"). The Supplemental Order provides that Ms. White may petition the Board for modification of the probationary terms after one (1) year of probation provided that she has fully complied with the terms of probation and has no pending complaints against her. Ms. White requests that she be released from the probationary conditions that, in a dispensing role: (1) require that she practice with another pharmacist on-site; (2) permit the she practice a maximum of 40 hours per week, 10 hours per shift; and (3) prohibit her from working as a floater or for a staffing agency. Upon consideration of Ms. White's request and a review of Ms. White's compliance with the terms of probation to date, the Board votes to modify the terms of probation as ordered below.

ORDER

It is this 10th day of Fahruary, 2012, by an affirmative vote of the Maryland Board of Pharmacy, hereby,

ORDERED that Ms. White may practice pharmacy as a dispensing pharmacist without the presence of another pharmacist on-site; and be it further,

ORDERED that Ms. White may work in a dispensing role as a floater or for a staffing agency; and be it further,

ORDERED that the remaining probationary terms are continued in this Order, to wit:

1. Ms. White shall submit to random Board-ordered urinalysis;

2. Ms. White shall attend NA/AA or other similar support group at least weekly and

provide the Board with attendance slips on a monthly basis;

3. Ms. White shall continue participating in the substance abuse program at Kolmac

clinic or other similar program and be compliant with program requirements and

recommendations;

4. Ms. White shall insure that the substance abuse program provides the Board with

monthly progress reports;

5. Ms. White shall engage in counseling focused on effective stress management and

insure that the therapist or counselor provides the Board with monthly progress reports;

6. In a dispensing role, Ms. White may practice a maximum of 40 hours per week, 10

hours per shift;

7. In a dispensing role, Ms. White shall provide a copy of the Supplemental Order, along

with this Order, to her pharmacy employer and insure that the employer complete and return to

the Board an Employer Verification Form; and be it further,

ORDERED, as set forth in the Supplemental Order, dated January 5, 2011, that Ms.

White may petition to terminate probation no sooner than January 5, 2015; and be it further,

ORDERED that all other terms of the Supplemental Order dated January 5, 2011, remain

in full force and effect; and be it further,

ORDERED that this is a formal order of the Maryland Board of Pharmacy and as such is

a public document pursuant to the Maryland Annotated Code, State Government Article, Section

10-617(h).
