- TB (tuberculosis) natna ka neih lam/ neih khak ding lam ka thei hi.
- TB pen mimai ah ka khuhciang, pau ciang, lasak ciang ki lawh theih lam ka thei hi.
- TB natna pan dam na dingin zatui kum 2 sung bang nek kul ding cih ka thei hi.
- Ka Siavuan in TB ka neih lam Kumpilam thukhun tawh ki zui in Health Department (Natna lam tawh kisai zum) te kiang a koh kul cih ka thei hi.
- TB natna kakiim kapaam aa te ka lawhloh nang leh, TB natna pan ka dam nang Health Department (Natna lam tawh kisai zum) te in mawhpuak in hong la ding cih ka thei hi.
- Ka TB zatui te a hunmaan in ka nek kei leh, Health Department (Natna lam tawh kisai zum) te in thu hong bawl thei uh hi cih ka thei hi.

- Health Department TB program Natna lam tawh kisai zum) te hong sawl bang in TB natna tawh ki sai appointment in a hunsim in ka pai ding hi.
- Hong sawl bang un TB natna tawh ki sai hong sit-telna khempeuh (Ciltui, Awm X-ray, laboratory atuamtuam) ka phal/ka zui ding hi.
- Ka TB zatui hongan bangun ka ne ding hi, DOT (Direct Observation Therapy) zong a hunzui in ka hih ding hi.

- Health Department (Natna lam tawh kisai zum) te kiang ah kei aa leh ka taangmi aa ka koih pa/nu' teenna, ka phone nambat te a ki laih leh ka zasak pah ding hi.
