What is comprehensive cancer control?


- Per the Centers for Disease Control and Prevention, comprehensive cancer control is a strategic approach
 - to prevent or minimize the impact of cancer in communities
 - that brings together key partners and organizations to develop a plan to reduce the number of <u>community members</u> who get or die from cancer
- Maryland Comprehensive Cancer Control Program at MDH implements these approaches and supports the Maryland Cancer Collaborative (MCC)



Maryland Cancer Collaborative (MCC)

- Statewide coalition of volunteers who implement the Maryland Comprehensive Control Plan.
- Work with individuals and organizations throughout the state to implement the Maryland Comprehensive Cancer Control Plan.
- Bring together existing groups and new partners from across the state to collaborate on a common goal: reducing the burden of cancer in Maryland.

New Priority Strategies include topics on:

- **Tobacco Cessation**
- **HPV Vaccination**
- Underappreciated and lesser known risk factors for cancer (alcohol consumption, hepatitis, radon exposure)
- Targeted outreach and education to minority and other underserved populations
- Survivorship care plans, palliative and hospice care awareness



Tobacco Cessation Workgroup Update

Strategy: Educate Maryland hospitals about the importance of and encourage adoption of policies to provide inpatient counseling and treatment for patients who use tobacco **Co-Chairs:** *Krystle F. Pierce*, Project Director, MDQuit Resource Center, & *Joanne H. Ebner*, Manager, Cancer Prevention Department & Anne Arundel Medical Center

Project: Conducted a survey of Maryland hospitals to assess the level of inpatient tobacco treatment services along with tobacco protocol & policies.

<u>All hospitals are offering some type of referral treatment</u>: NRT; Referral to 1-800-Quit-Now; Self Help Materials; Counseling; Referrals.

<u>Next Steps:</u> Using the information gathered from the survey to assist hospitals in developing & implementing evidence-based tobacco treatment services for inpatients by providing information and resources.

Access to Care and Services Workgroup

Strategy: To ensure cultural, financial, and geographic access and provide information to underserved populations on how to access healthcare and supportive services.

Chair: Patsy Astarita, LCSW-C, OSW-C, Manager, Supportive Care & Community Services University of Maryland, Upper Chesapeake Health Kaufman Cancer Center

Project: Conducted a survey of providers at primary care centers and cancer centers regarding demographics of their patient populations and what type of resources would meet their needs.

Developing a resource guide for providers and office staff to raise awareness of cultural sensitivity issues and provide materials to further their learning on the burden of cancer in Maryland among disparate populations.

<u>Next Steps:</u> Plans to disseminate via MCC communication venues and through Workgroup member channels.



Hospice Data Utilization Workgroup

Strategy: Create partnerships to develop and implement a plan to collect cancer patient hospice utilization data.

Co-Chairs: Peggy Funk, Hospice and Palliative Care Network of Maryland, & Michele Levin, Gilchrist

Project: Identified available hospice data and current gaps in existing data, survey hospices to gather additional data, as well as solicit Maryland Healthcare Commission to expand the data that is current being collected in the Annual Hospice Survey. The Workgroup reached out to Maryland Hospice providers requesting completion of brief survey to provide 2016/17 data, and asked the Maryland Healthcare Commission to add additional questions to Annual Hospice Survey to collect data in future surveys.

<u>Future Plans:</u> Once data has been collected it will be used to track hospice utilization increases/decreases among patients with the primary diagnosis of cancer and their length of stay.



HPV Vaccination Workgroup

Strategy: Implement systems changes within healthcare practices to check teenage patients' vaccination status and offer all indicated vaccines at each visit; schedule the next HPV vaccination dose before the end of the current appointment; and, utilize reminder and recall strategies.

Chair: Dr. Niharika Khanna, University of Maryland

Projects:

Anne Arundel Pediatric Offices: Provide various education events for providers (CME opportunities) and parents (community outreach); training and resources for pediatric offices, including toolkits, signage, best practices.

<u>HPV vaccine "Catch-Up" Project:</u> UMBC champions HPV Vaccine among students through systems changes and campus education and outreach.

<u>HPV Vaccine Encouragement Letters to Universities and Colleges:</u> Distributed letters to heads of colleges and universities to encourage leadership to champion HPV vaccine and reach out to MDH for additional resources.



Communications Workgroup

Strategy: To use media outlets such as websites and social media outlets; print, radio, and television PSAs; billboards; and press releases to provide public health messages related to cancer.
