Description of Colonoscopy Feedback Reports

The Colonoscopy Feedback Report is composed of the following three sub-reports which are explained in detail below: the 1) All Provider Report, 2) the Individual Provider Report, and (where applicable) the 3) Multi-Program Report.

1) All Provider Report

A statewide All Provider Report has been furnished for this year's quality review of screening colonoscopies performed by all contracted Providers in the Cigarette Restitution Fund's (CRF) Cancer Prevention, Screening, Education, and Treatment (CPEST) Program. The report covers the time period from January 1, 2016 to December 31, 2016.

The All Provider Report contains the following information in a table:

- An evaluation of the first colonoscopy performed in a screening cycle.
 - The evaluation includes information on the percent of adequate exams (a combination of adequate bowel preparations and reaching the cecum), the percent of colonoscopies with adequate bowel preparation, percent of exams where the cecum was reached, and the percent of exams where the cecum was reached AMONG those with an adequate bowel preparation.
 - Note: If a client had more than one colonoscopy in a cycle, only the first colonoscopy was evaluated. If a client had two or more screening cycles in this period, the first colonoscopy in each screening cycle was evaluated.
- The biopsy rate among all screening colonoscopies performed and the number of colonoscopies identified with adenoma or serrated polyp, where size is missing.
- The findings of ADEQUATE first screening colonoscopies performed on clients age 50 years or older who did not report bleeding. This includes the percent of colonoscopies in which neoplasia was detected as the most advanced lesion(s), the percent of colonoscopies where hyperplastic polyp(s) were the most advanced lesion, and the percent of colonoscopies with hyperplastic polyps or neoplasia.

Ranges noted in the All Provider Report are the minimum and maximum value among providers in the CRF-CPEST program who performed 30 or more colonoscopies during the time period of January 1, 2016 to December 31, 2016, unless noted otherwise.

2) Individual Provider Report

The format for the Individual Provider Report is similar to that of the All Provider Report, except it does not include ranges for various measures. The Individual Provider Report is generated for each Provider, for each period in which they performed one or more colonoscopy procedures for that specific program, unless the Provider performed colonoscopy procedures for multiple programs (see Multi-Program section below).

3) Multi-Program Reports

Some Providers provide services for more than one program. In these cases, each of programs the Provider is contracted with will receive a Multi-Program Report of all colonoscopies performed by that Provider for all programs.
