I. WELCOME

II. APPROVAL OF MINUTES

III. OLD BUSINESS

Open Meetings Act

• Bethan Haaga, Assistant Attorney General representing Public Health Services gave an overview of the Open Meetings Act to the Committee and explained the processes.

- It was mentioned that the subcommittee was efficient, and it was recommended to do it again.
- Council members were asked if they were interested in joining in reviewing the curriculum.
- Kimberly Townsend and Lisa Guy agreed to split it up and review the curriculum. They will touch base and decide what sections to review and decide when to bring it back to the Committee when ready.

IV. NEW BUSINESS

Impact of SB944

- Senate Bill 944 was passed but it has not been signed into law yet.
- The Council discussed SB944 potential impact to local Health Departments.
- Being required to have OTC contraceptives or it being an option for LHD's to have them
 or offer them was an impact discussed with the Committee and it effecting the
 formulary.
- The Council discussed the bill, the amended bill and their concerns.
- Having the FDA link available was suggested to the Council because an updated list of over the counter drugs would be exhausting.
- Kimberly Townsend suggested revisiting this SB944 discussion at the next meeting, and in the meantime, she will check the FDA website and see how many medications on that list are contraceptives.
- Theresa Wavra suggested that if the Committee wanted to finish up the rest of the open meeting, they can close the meeting and ask more specific SB944 questions with their remaining 10 minutes.
