Introduction

The Annual and Validation School Immunization Surveys are administered annually to gather information on the vaccination status of children enrolled in Maryland schools from Kindergarten through Grade 12. The data collected are used to assess compliance with Maryland school immunization requirements as required by Department of Health and Mental Hygiene (DHMH) Code of Maryland Regulations (COMAR) 10.06.04.03, ensure high immunization coverage in school-aged children, and to identify geographic areas/populations in need of improved immunization coverage. This summary report describes the results of the Maryland Annual and Validation School Immunization Surveys administered for the 2011-2012 school year.

Survey Descriptions

The Annual and Validation School Immunization Surveys assess immunization coverage for vaccines which are required for school entry: Diphtheria, Tetanus, Pertussis (DTaP/DTP/Tdap/DT/Td), Polio, Measles, Rubella, Mumps, Hepatitis B, and Varicella. Students must be vaccinated with the following antigens: 4 doses of diphtheria, tetanus and pertussis; 3 doses of polio and hepatitis B; 2 doses of measles; 1 dose each of mumps, rubella and varicella.

The surveys also collect information on the percentage of students with immunization records and the percentage of students reporting medical or religious exemptions from vaccination.

Survey respondents are asked to obtain information from the immunization records of: (1) *all* kindergarten students and (2) *newly* enrolled students in grades 1-12. The immunization status of students enrolled in non-graded programs is also assessed and included in the survey.

The Annual School Immunization Survey collects information for students enrolled in Maryland public *and* private schools. The survey collects cross-sectional data, at a single point in time. Changes in vaccination coverage, due to shifting student enrollment after initial submission of the survey, are not captured. Vaccinations that are completed after the day of assessment are not included in the survey. Survey respondents are typically school nurses and/or other school administrators who have access to student immunization records.

According to COMAR 10.06.04.09, all Maryland schools are required to report the immunization status of students who are new to the school. Reports are submitted to the Department of Health and Mental Hygiene (DHMH) on an annual basis by November 15.

The Validation School Immunization Survey collects information from a sample of students enrolled in private schools in Maryland. The Validation School Immunization Survey does not collect information from public schools. The survey is distributed to local health departments (LHDs) that are then responsible for assessing the immunization

status in a sample of students from at least 20% of the private schools in their jurisdiction. LHDs may select the schools to include in the survey, but are asked to select schools on a rotating schedule to avoid biases. From a selected sample of students, the survey respondent conducts an initial immunization status assessment. Students not in compliance with immunization requirements are given a 20 day grace period to obtain the required immunizations and/or documentation of status. A second and final assessment is completed 30 days after the initial assessment. Both the initial and final assessments collect cross-sectional data, at a single point in time. Vaccinations that are completed after the final assessment are not included in the survey. Survey respondents are typically LHD infection control nurses and administrators. LHDs are required to submit survey results to the Department of Health and Mental Hygiene (DHMH) on an annual basis by April 1.

Annual and Validation School Immunization Survey results are compared in efforts to validate and identify any significant variability and/or discrepancies in the immunization data collected. Survey results are submitted annually to the Centers for Disease Control and Prevention (CDC) per federal grant requirements.

Methods

The Annual School Immunization Surveys were distributed on August 5, 2011 and were due on November 11, 2011. Annual School Immunization Surveys were mailed directly to all public and private schools registered with the Maryland Department of Education. The Validation School Immunization Survey was distributed on November 30, 2011 and was due on April 1, 2012. As survey respondents are the LHDs, each jurisdiction was notified of the survey and provided survey materials by Health Officer Memo. LHD staff selected at least 20% of their jurisdiction's private schools for the survey. Surveys were submitted to the Maryland Department of Health and Mental Hygiene Center for Immunization. Annual and validation survey respondents submitted their responses online at http://ideha.dhmh.maryland.gov, by fax or by mail. Results were compiled and reviewed for completeness; individual respondents were contacted regarding inconsistent data or information requiring clarification.

Results

The following describes results obtained from the 2011-2012 Annual and Validation School Immunization Surveys. The results are summarized in Table 1.

Students Enrolled in Kindergarten

Immunization Coverage

During the 2011-2012 school year, Annual School Immunization Survey data were collected on 49,024 kindergarten students in Maryland. Of these students, 48,485 students (98.9%) were considered non-exempt from vaccination and had immunization records on file with the school. Maryland's immunization coverage among kindergarten students exceeded 99% for all vaccines required for school entry except measles (98.7%) (Table 1). Immunization coverage did not vary among the 24 jurisdictions in the State.

All counties achieved greater than 98% immunization coverage for all of the required antigens with the exception of Baltimore County (range from 95.4% - 97.9% for all required antigens), Prince George's County (range from 95.2% - 97.8% for all required antigens), Washington County (96.7% for measles only), and Wicomico County (93.8% for measles only). Garrett and Dorchester Counties achieved 100% immunization coverage for all of the required antigens.


Frederick county reported 93.3% of Kindergarten students with immunization records. Baltimore county reported 97.9%. Prince George's, Montgomery, Washington, and Baltimore City reported between 98.3 % – 98.9%. Anne Arundel, Carroll, Cecil, Harford, Howard, St. Mary's, Talbot, and Wicomico reported between 99.4% - 99.9% of Kindergarten students with immunization records. The following counties reported 100% of Kindergarten students with immunization records: Calvert, Allegany, Caroline, Charles, Dorcester, Garrett, Kent, Queen Anne's, and Worcester. Somerset county did not include information about their kindergarten population. The data is self-reported by schools of all kindergarten enrollees. All numbers reflect immunization status of surveyed students, not all students in the jurisdiction.

The immunization coverage for the 2011-2012 school year did not differ notably from the immunization coverage reported during the 2010-2011 school year. Immunization coverage for DTaP, polio, measles, rubella, mumps hepatitis B, and varicella vaccines was 0.1 to 0.4 percentage points higher in the 2011-2012 school year, as compared to the 2010-2011 school year (see table 1 and Appendix 1).

The Validation School Immunization Survey results for kindergarten students were similar to the results of the Annual School Immunization Survey. The Validation School Immunization Survey was administered for 239 private schools and data were collected on 3,032 kindergarten students. Although a majority of the immunization rates reported in the Validation School Immunization Survey were lower than the immunization rates reported in the Annual School Immunization Survey, the results confirmed that greater than 90% of kindergarteners in Maryland have received the vaccinations required for school entry.

All of the immunization rates reported in the Validation School Immunization Survey, with the exception of measles immunizations, are within 1 percentage point of the rates reported in the Annual School Immunization Survey. The immunization rate for measles is 98.7% according to the Annual School Immunization Survey and 92.2% according to the Validation School Immunization Survey (Figure 2). Validation survey data were not available for Garrett County because there were no kindergarteners enrolled in the schools included in their sample.




Of note, the immunization coverage for measles vaccination is lower than the coverage for mumps and rubella vaccination, despite the fact that the vaccines are typically administered in a combination shot, MMR. This trend is consistent in the 2011-2012 school year surveys as well as in previous school surveys. This can be possibly explained by the fact that 2 doses of measles antigen is required for school entry, whereas only 1 dose of mumps and 1 dose of rubella antigen are required. As a result, a lower measles immunization rate, as compared to mumps or rubella immunization rate, likely reflects a lack of compliance with obtaining the second required dose of MMR vaccine since obtaining only one MMR satisfies the requirements for mumps and rubella vaccination but not the requirement for measles vaccination. Therefore, this lack of compliance with obtaining the second MMR dose has a greater effect on the measles immunization coverage that is calculated.

Immunization Exemptions


In the 2011-2012 school year, medical exemption rates were reported as 0.3% in the Annual School Immunization Survey and 0.4% in the Validation School Immunization Survey. These percentages are similar to those reported for the 2010-2011 school year in which 0.4% of kindergarteners were medically exempt according to the Annual School Immunization Survey and 0.4% of students were medically exempt according to the Validation School Immunization Survey (Figure 2).

According to the Annual School Immunization Survey, 0.6% of Maryland kindergarteners claimed a religious exemption from vaccination; 1.0% of the students captured in the Validation School Immunization Survey reported a religious exemption. (Figure 4) These results are comparable to the exemption percentages reported for kindergarteners in the 2010-2011 school year: 0.5% religious exemption (Annual School Immunization Survey) and 0.8% religious exemption (Validation School Immunization Survey).

Immunization Coverage


The 2011-2012 Annual School Immunization Survey collected data on 576,800 students enrolled in grades 1-12 in Maryland. Immunization records were available for 574,493 (99.6%) students who were considered non-exempt from immunization. A high level of vaccination was achieved for all of the required school-entry vaccinations (Table 1). Vaccination rates were 99.9% for all vaccines required for school entry. Immunization coverage did not vary significantly among the 24 jurisdictions in the State, with all counties achieving greater than 98% immunization coverage. Calvert, Caroline, Cecil, and Somerset Counties obtained 100% coverage for all required vaccinations.

Charles county reported 93.7% of students grades 1-12 with immunization records. Allegany, Baltimore County, Baltimore City, Frederick, Kent, Montgomery, Prince George's, Queen Anne's, Talbot, Washington and Wicomico reported between 98.9% – 99.9%. The following counties reported 100% of students grades 1-12 with immunization records: Anne Arundel, Calvert, Caroline, Carroll, Cecil, Dorchester, Garrett, Harford, Howard, Somerset, St. Mary's and Worcester. (Figure 5). The data is self-reported by schools of all enrollees grades 1-12. All numbers reflect immunization status of surveyed students, not all students in the jurisdiction.

Immunization coverage in the 2011-2012 school year did not differ significantly from coverage in the previous school year (see Appendix 1). Immunization coverage for DTaP, polio, measles, rubella, mumps, hepatitis B, and varicella was 0.3 to 0.7 percentage points higher in the 2011-2012 school year, as compared to the 2010-2011 school year. Maryland achieved 99.9% immunization coverage for students enrolled in grades 1-12 for all antigens in the 2011-2012 school year.

For the Validation School Immunization Survey, 239 private schools were surveyed and data were obtained from a sample of 4,636 students enrolled in grades 1-12. The results obtained from the Validation School Immunization Survey were consistent with the immunization rates reported in the Annual School Immunization Survey; the immunization rates reported for both surveys were within approximately 2.0 percentage point of each other and confirm a high rate of immunization in grade 1-12 students (Figure 4).



Immunization Exemptions


According to the Annual School Immunization Survey, 0.1% of Maryland school children enrolled in grades 1-12 were medically exempt from immunization. According to the Validation School Immunization Survey, 0.3% of children enrolled in grades 1-12 were medically exempt. In the school year 2010-2011, medical exemptions were reported by 0.1% of students in the Annual School Immunization Survey and by 0.2% of students in the Validation School Immunization Survey (Figure 5).

According to the Annual School Immunization Survey, 0.1% of Maryland students in grades 1-12 claimed a religious exemption from vaccination; 1.4% of students claimed a religious exemption in the Validation School Immunization Survey. The reason for the 1 percentage point different in medical exemption rates reported in the Annual and Validation Immunization Surveys is unclear. In the 2010-2011 school year, 0.1% of students reported a religious exemption in the Annual School Immunization Survey and 1.2% reported a religious exemption in the Validation School Immunization Survey (Figure 6).





Limitations

The data obtained are *estimates* of the immunization coverage of school children in Maryland. Maryland does not mandate routine reporting of immunizations to a centralized registry. As a result, data gathered through these surveys were obtained through self-report by nurses, volunteers, infectious disease control officers and other health personnel at schools and at the local health department. Reporting discrepancies and human error in reporting may lead to slight differences in immunization coverage between jurisdictions, as well as in data reported from year-to-year.

The data in the report reflect the immunization status of *surveyed* students, not all students in the jurisdiction. Also, a small proportion of students did not have immunization records and their immunization statuses were unknown.

Conclusion

The surveys estimate that more than 97% of children enrolled in Maryland schools have received all required vaccinations for school-entry, with fewer than 2% of children requesting medical or religious exemptions from vaccination.

The DHMH Center for Immunization will continue to monitor immunization coverage in all jurisdictions to ensure that Maryland residents remain protected from vaccine-preventable diseases.

IV. Procedures

A. Instructions to Access the Online Survey

B. Survey Questions – General Information

- **Question 1:** Complete all contact information (name of person completing the report/primary contact person, phone number, and e-mail address) as indicated.
- **Question 2:** Enter the date the report was completed. (It is not necessary to enter the time.)
- **Question 3:** Complete all school information (school name, phone number, mailing address, county/jurisdiction, and type of school) as indicated. Please be sure to make the distinction between Baltimore County and Baltimore

City. Record the grade levels for your school (e.g., grades 1-5). Nongraded schools should be noted here as well.

- **Question 4:** Record the "*Total number of students currently enrolled in the entire school*" by grade level. This count should be based on all students, regardless of whether (1) they are newly enrolled (or not) or (2) have medical/religious exemptions.
- Question 5: The "Number of students with immunization records" is a count of all current students enrolled in Kindergarten and only newly enrolled students in grades 1-12. Do not include students with exemptions in this count.
- Question 6: The "Number of students <u>without</u> immunization records" is a count of all current students enrolled in Kindergarten and only newly enrolled students in grades 1-12. Do not include students with exemptions in this count.
- Question 7: The "Total number of student records being reviewed" is a count of the total number of student immunization records. Do not include students with exemptions in this count.

 Note: this number should equal the sum of the responses in questions #5 and #6.
- Question 8: The "Number of students who have a medical exemption" is a count of all current students enrolled in Kindergarten and only new student enrollees in grades 1-12 with a documented (by a health care provider) medical exemption or contraindication on file.

 Note: Students with medical exemptions should not be included in your record review and in the number of students with or without immunization
- Question 9: The "Number of students who have a <u>religious exemption</u>" is a count of all current students in Kindergarten and only new student enrollees in grades 1-12 whose parents have signed the religious exemption portion of the official Maryland Immunization Certificate (DHMH 896).

 Note: Students with religious exemptions <u>should not be included</u> in your record review and in the number of students with or without immunization records.

C. Survey Questions - Immunization Status

The questions in this section (questions 10-16) are designed to assess the number of students with immunization records who NEED (i.e.; ARE MISSING) one or more of the following vaccine doses listed. Please refer to the "Vaccine Requirements for Children Enrolled in Pre-School Programs and in Schools, Maryland School Year 2011-2012" to determine age-appropriate immunity for Kindergarten through grade 12 enrollees.

- **REMEMBER:** For all questions only include <u>all current students enrolled in Kindergarten</u> and only <u>newly enrolled students in grades 1-12</u>. Students with exemptions <u>are not</u> counted as students needing a dose of vaccine.
- **EXAMPLE:** If one newly enrolled student in 3rd grade needs one dose of Polio vaccine; **AND** one newly enrolled student in 4th grade needs two doses of Polio vaccine; **THEN** the TOTAL number of students needing one or more doses of Polio vaccines is **TWO**.
- **Question 10:** Provide a count of all students enrolled in Kindergarten and only newly enrolled students in grades 1-12, by grade, who have less than the required number of DTaP/Td/DT vaccinations, depending on age and grade (see minimum vaccine requirements). Do not include exemptions.
- **Question 11:** Provide a count of all students enrolled in Kindergarten and only newly enrolled students in grades 1-12, by grade, who have less than the required **3** doses of Polio vaccine. Do not include exemptions.
- **Question 12:** Provide a count of all students enrolled in Kindergarten and only newly enrolled students in grades 1-12, by grade, who have <u>less than</u> the required **2** doses of Measles vaccine. Do not include exemptions.
- Question 13: Provide a count of all students enrolled in Kindergarten and only newly enrolled students in grades 1-12, by grade, who have <u>0</u> doses of Rubella vaccine. Do not include exemptions.
- **Question 14:** Provide a count of all current students enrolled in Kindergarten and only newly enrolled students in grades 1-12, by grade, who have $\underline{\mathbf{0}}$ doses of Mumps vaccine. Do not include exemptions.

- Question 15: Provide a count of all current students enrolled in Kindergarten and only newly enrolled students in grades 1-11 who have less than the required 3 doses of Hepatitis B vaccine. Do not include exemptions.
- Question 16: Provide a count of all current students enrolled in Kindergarten and only newly enrolled students in grades 1-11 who have less than the required doses of Varicella vaccine, depending on age and grade (see minimum vaccine requirements) and no history of chickenpox disease. Do not include exemptions.
- **Question 17:** Provide the method (DHMH Form 896 or another method) your school uses to document student immunization information.

V. Frequently Asked Questions

- 1. Should I review the records of <u>all</u> students in grades K-12?
 - ✓ For kindergarten students: Yes. <u>All</u> kindergarten records should be reviewed, including records of students who were enrolled in your pre-school program the prior year.
 - ✓ For students in grades 1-12: No. You should only review the records of students who are <u>newly enrolled</u> for this academic year.
- 2. For questions 4-7, how do I calculate the *total number of students enrolled* if I am only reviewing students who are newly enrolled in grades 1-12?
 - ✓ Question 4 refers to <u>all students in your school (grades K-12)</u>, regardless of whether they are newly enrolled or not.
 - ✓ Questions 5-6 refer to <u>all kindergarten students</u> and <u>only newly enrolled</u> students in grades 1-12. Do not include children with medical exemptions in this count.
 - ✓ Question 7 refers to the number of records you are reviewing for this survey. When responding to question 7, the total number of student records being reviewed should ALWAYS equal:

- Question 5: the number of children with records (among kindergarten students and only newly enrolled students in grades 1-12, excluding exemptions);
 - + PLUS
- Question 6: the number of children <u>without</u> records (among <u>kindergarten students</u> and <u>only newly enrolled</u> students in grades 1-12, excluding exemptions);

You should attempt to collect immunization information on students whose records were missing on the day of your initial assessment.

3. Do I have to complete the survey if my school <u>only</u> includes pre-school or pre-kindergarten?

✓ No. Preschool and pre-kindergarten are not included in this year's survey. Only grades K-12 are included.

Question 1: Complete all county contact information (name, phone, mailing address, email address and person completing report) as indicated.

Question 2: Enter the date the report was completed. (It is not necessary to enter the time.)

- **Question 3:** Provide the total number of private schools, grades K-12 only, in your jurisdiction. A school that teaches nursery, Pre-k, and Kindergarten should be included in your sample because Kindergarten is included in our target population.
- **Question 4:** Provide the total number of private schools, grades K-12 only, audited. This number should be at least 20% of the number recorded in Question 3.
- Question 5: The "*Total number of students enrolled*" is a count of all current students enrolled in Kindergarten and only **new** student enrollees in grades 1-12.

Question 6: Provide the "*Total number of records reviewed*" by grade.

Note: Questions #7-20 only refer to those students selected for your record review, not the entire student population of the school, unless you have included all students in your sample.
