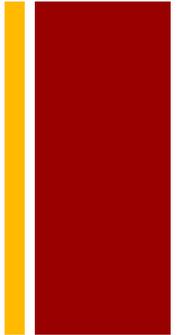

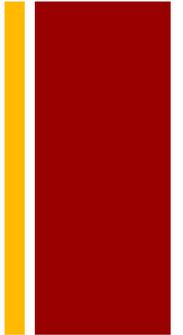
About MDAC

Untreated Oral Health Disease - Costly Health Disparity



- **14.1% of Maryland's population is 65+ years of age**
 - 848,319 people
 - 52% female and 48% male
- **Tooth loss is highest among older adults, African-Americans, low income people & adults with lower education levels**
 - More than 1/3 of low income elderly have lost all their teeth
 - 72% of tooth loss occurs to adults 65+
- **Poor oral health increases the risk of chronic disease such as diabetes and heart disease**
- **Poor oral health can result in lost workdays and unemployment**

Oral Health Care for Low Income Adults - Fragile Safety Net

- **MD Medicaid Program does not include oral health care for adults**
 - **Most MD MCOs offer a limited oral health benefit**
- **Emergency departments provide emergent care for “oral health pain”**
 - **EDs do not treat causation of oral health pain**
 - **Refer patients to community-based provider**
 - **Community-based oral health resources limited**
 - **Local community “oral health access” programs**
 - **Health Department oral health programs**
 - **Missions of Mercy**
 - **UM School of Dentistry**
 - **Private practitioners; reduced fees/free care**
 - **FQHC oral health services/sliding fee scale**

Adults Seeking Access to Oral Health Care



State Medicaid Coverage of Adult Dental Benefits by Type of Beneficiary Population (Base or Expansion)

Extensive	15 states: AK, CA , CT , IA , MA , NJ , NM , NY , NC, ND , OH , OR , RI , WA , WI	11 states: CA, CT, IA, MA, NJ, NM, NY, OH, OR, RI, WA

 - **Reduce absenteeism**

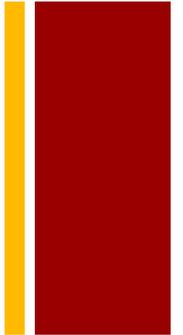
MDAC at Work

- **Continue to strengthen & build the Coalition**
- **Passage of SB169 (including HB1158)**
- **Emergency Department Use study**
- **Publish Maryland Oral Health Plan (MOHP)**
- **Work with partners throughout MD to build groundswell of support to add adult oral health services to Medicaid**
- **Work with MD Congressional delegation to educate & build support for adding oral health benefits to Medicare**

Next Steps - Collaborate to Succeed

- **Continue to meet with people throughout MD to learn about local efforts to provide oral health services for adults/older adults**
- **Encourage individuals & organizations to join MDAC, partnering with us to ensure adult oral health services are added to the Medicaid benefit**
- **Publish the Maryland Oral Health Plan in August 2017**
 - **MOHP is a broad framework & a living document**
 - **Meet with local communities to collaboratively develop strategies for achieving MOHP goals**
- **Be active participants in the implementation of adult oral health services to address workforce challenges, ensure network adequacy & timely access to services**
