As a requirement of your WIC authorization, and in accordance with Code of Maryland Regulations 10.54.03.15B(1)(r), all authorized vendors must have a representative attend and participate in at least one State or local agency interactive training session each calendar year. **Failure to satisfy the annual training requirement may result in the disqualification of your store's WIC authorization.**

This year, we will be holding in-person classes **and** GoToWebinar meetings in multiple languages. If you choose to attend training by GoToWebinar, attendance will be monitored. You must remain online for the entire webinar. **Anyone that leaves the webinar early will not receive credit for attending and will be required to attend another webinar.**
