A reminder regarding vaccination coverage

We consider vaccinations medically necessary according to the recommendations from the Centers for Disease Control and Prevention (CDC) Advisory Committee on Immunization Practices (ACIP). You can read more about vaccination coverage by consulting our <u>coverage policy bulletins</u>. Use the search term "vaccination."

Changes to our National Precertification List (NPL)

The following new-to-market drugs require precertification:*

- Fyarro[™] (nab-sirolimus) precertification is required effective March 15, 2022.
- Vyvgart[™] (Efgartigimod Alfa-fcab) precertification is required effective March 15, 2022. This drug is part of the immunologic drug category.
- Leqvio[®] (inclisiran) precertification is required effective March 23, 2022. This drug is part of the cardiovascular inhibitors drug category.
- TezspireTM (tezepelumab-ekko) precertification is required for the drug and site of care effective March 23, 2022. This drug is part of the respiratory injectables drug category.
