Topic of the day

Our Clinical Policy Bulletins and search options are undergoing a makeover.

Aetna's Clinical Policy Bulletins (CPBs) are internally developed policies that we use as a guide for determining health care coverage for our members — your patients.

They are written on selected clinical issues, especially addressing new medical technologies such as devices, drugs, procedures and techniques. The CPBs are used as a tool to be interpreted in

conjunction with your patients' specific benefits plan and after discussions between you and your patients.

CPBs are based on:

- · Peer reviewed published journals
- A review of available studies on a particular topic
- Evidence-based consensus statements
- Expert opinions of industry professionals
- Guidelines from nationally recognized health care organizations

Our CPBs are currently undergoing a makeover to make it easier for you to search for and review them. You'll notice that now you can search CPBs on our medical clinical policy bulletins page by selecting the following tabs:

- Keyword search Enter your keyword or four-digit CPB number.
- · Alphabetical and category list You can refine your search to include categories such as Administrative (Non-Clinical), Behavioral Health, Drugs/Biologics, Medical and much more.
- What's new Here you can review additions, revisions, updates and deletions sorted by an enhanced chronological date range.
- Periodic review Identify the anticipated start dates of the CPB review process for each CPB listed (subject to change without notice at Aetna's discretion).

We've also updated the format within some CPBs to include:

- A table of contents with links to applicable CPT/HCPCS/ICD-10 codes to further clarify our coverage decisions
- A new policy section segmented by medical necessity; experimental and investigational; and cosmetic classifications
- A new glossary of terms
