## Adult Immunizations (IZ) Reimbursement Survey -- Medicaid MCO's

March 2018 MDH sent a survey to all of the Maryland Medicaid MCO's to identify their policy for reimbursing LHD's for adult IZ services.

Some LHD's provide private vaccines to adult Medicaid patient's and have had difficulty being reimbursed.
