Mandated Activities

<u>SB626 (2022)</u>, <u>Article – Health – General §§ 24–1701 – 1708</u>

The Council Shall:

- (1) <u>Seek permanent and diverse revenue sources</u> to aid in the stability and further development of the Program;
- (2) Help ensure maximum use of Federal funds;
- (3) Use available data and information to help direct funding to priority areas;
- (4) Monitor similar loan programs in other states and ensure that the Program remains competitive;
- (5) Assist the Department in the administration of the Program;



Mandated Activities

The Council Shall:

(6) Help <u>market and raise awareness</u> of the Program through educational institutions and other appropriate entities as an incentive to health care providers to practice in underserved areas;

Administratively, the Council shall:

- (1) Meet at least three times per year
- (2) On or before October 1 each year, the Council shall <u>report to</u> the Governor and the General Assembly on the activities of the Council and recommendations on any necessary changes to the Program

State Loan Repayment Program (SLRP)

- Notice of Funding Opportunity (NOFO): <u>HRSA-26-015</u>
- Project Period: July 1, 2026 June 30, 2029
- Project Ceiling: \$1M per year
- Alterations:
 - Increases the maximum fed award to \$75,000 for full-time primary care medical providers
 - Reinstitutes 1:1 match (non-federal: federal) requirement
 - Disallows administrative funding
- Application deadline: January 12, 2026
- Expected award date: April 1, 2026

FY 2025 Application Cycle

- 504 applications received
 - Physician, physician assistant: 166
 - 54 ineligible (Examples: incomplete, current service obligation)
 - APRN, RN, LPN, nursing support staff: 338
 - 163 ineligible (Examples: incomplete, current service obligation, practice site eligibility)
- 275 complete and eligible applications
 - Reviewed, tiered (SLRP eligible, primary care, emergency medicine, specialists (rural/non-rural), scored
 - Physician, physician assistant: 112
 - APRN, RN, LPN: 163



FY 2025 Application Cycle

- 138 awards offered
 - Physician, physician assistant: 61
 - APRN, RN, LPN: 77
- Funds obligated: FY26 and FY27



Applications and Awardees by Profession






Applicant and Awardee Practice Specialty by Profession


Awardee Practice Site Types by Profession

Draft Recommendations

Reiterating 2024 recommendations to General Assembly:

- Incorporate workforce development benefits such as educational loan repayment for healthcare professions into the AHEAD model.
- Broaden current MLARP PPA authorizing language to explicitly allow and invite funding sources to expand revenue sources.
- Include language in the MLARP PPA authorizing statute to specifically state participant exemption from state income tax, mirroring U.S. Department of the Treasury Internal Revenue Service practices (<u>Publication 970: Tax Benefits for Education</u>).
- Earmark State funds for the support of the costs associated with administration of MLRP operations.

DEPARTMENT OF HEALTH

Draft Recommendations

In addition, the Advisory Council specifically calls out the following recommendation:

The General Assembly should alter the requirement for an annual MLARP Advisory Council for Physicians and Physician Assistants report; Article-Health-General §24–1708 (g) to require a report every three (3) years to better allow the Council to fulfill its mandates and provide robust reporting:

"On or before October 1 each year, the Council shall report to the Governor and, in accordance with § 2–1257 of the State Government Article, the General Assembly on the activities and recommendations of the Council."
