Workshop: Attachment Based Family Therapy Training (ABFT)



Tuesday, May 25 at 9 a.m. - 5 p.m.

ABFT is a manualized, empirically supported family therapy model specifically designed to target family and individual processes associated with adolescent suicide and depression.

ABFT emerges from interpersonal theories that suggest adolescent and young adult internalizing disorders (e.g., depression, suicide, trauma, anxiety) can be precipitated, exacerbated, or buffered against by the quality of interpersonal relationships in families. It has also been used where family conflict is a contributor to the presenting problem. It is a trust-based, emotion-focused psychotherapy model that aims to repair interpersonal ruptures and rebuild an emotionally protective, secure-based parent-child relationship.

In this free workshop, you will learn about the theoretical principles ABFT is based on as well as the clinical strategies that comprise ABFT. Certificates of Attendance or CEUs will be provided.

Announcement: *Community Health Worker* (CHW) Certification Application

Applications for CHW certification based on experience will now be accepted through *June 30, 2021*. Visit the CHW Certification homepage for information about certification, full eligibility requirements, and application instructions. To apply for CHW certification based on experience:

- Log into Maryland OneStop
- Upload the required form of age verification and two letter of validation forms
- Submit the application

Once the experience pathway closes, the only pathway to CHW certification will be based on the completion of an accredited CHW certification training program!
