 - a. Had a huge role in the funding side for MLARP since inception and pretty invested in seeing it operate. Did a lot of research during legislative session and saw a lot of interesting things that other states were doing not only on the funding side but the data side as well such as identifying the community needs and obtaining workforce data and also being able to track program outcomes.
