Did You Know?

CareFirst Offers a Free Online CE Course

Continuing Education (CE) credits are a requirement for licensure. CareFirst BlueCross BlueShield and BlueChoice, Inc. (collectively, "CareFirst") wants to make it easier to fulfill this requirement by offering free online courses through our Learning and Engagement Center (LEC).

In February, CareFirst launched its first online, for-credit course, *Understanding Implicit Bias*, which takes a deep dive into the issue and the impact it has on the quality of care our members receive. It also aligns with our mission of promoting accessibility and equity for the members we serve.

Dentists should submit the certificate they receive from MedChi and any required supporting information to their dental boards, who will review it for credit toward their dental license. The MSBDA's requires new licensees to take an implicit bias course listed on the Office of Minority Health (OMH) site. Our course can be accessed there or through our Learning & Engagement Center.

Important Notes About the Course:

- Learners are required to complete a survey after the class to receive credit.
- Please bear in mind that it can take up to a month to process survey information.
