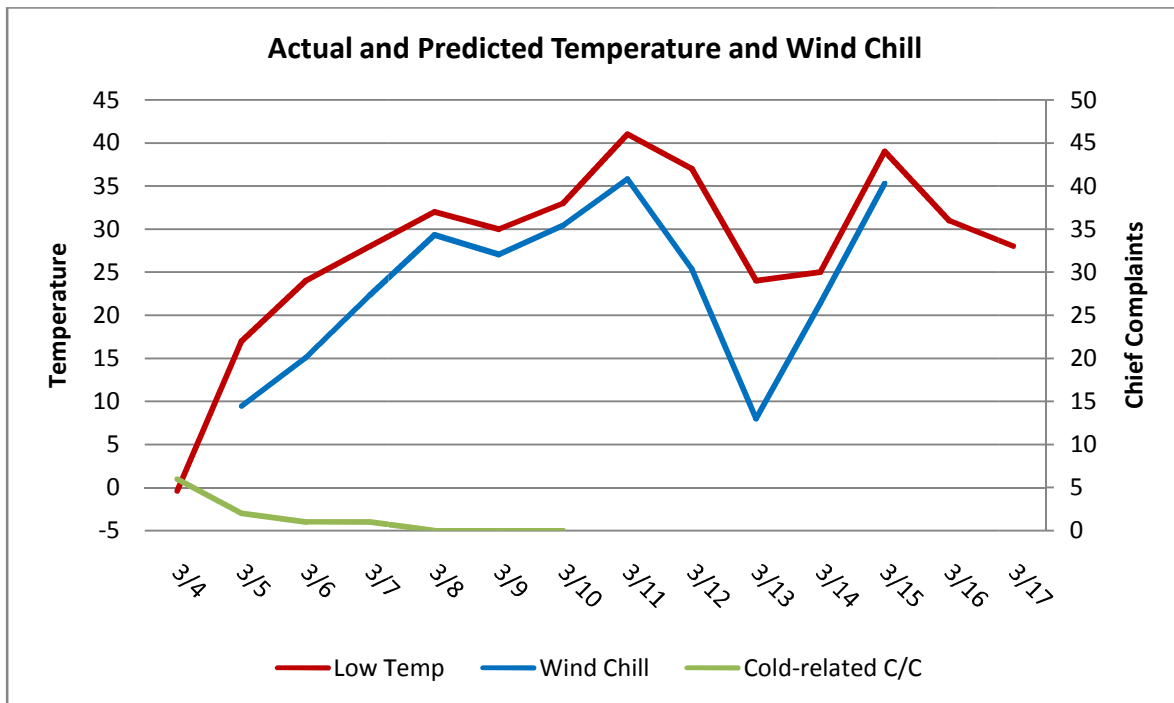

Reporting for 03/04/14 through 03/10/14

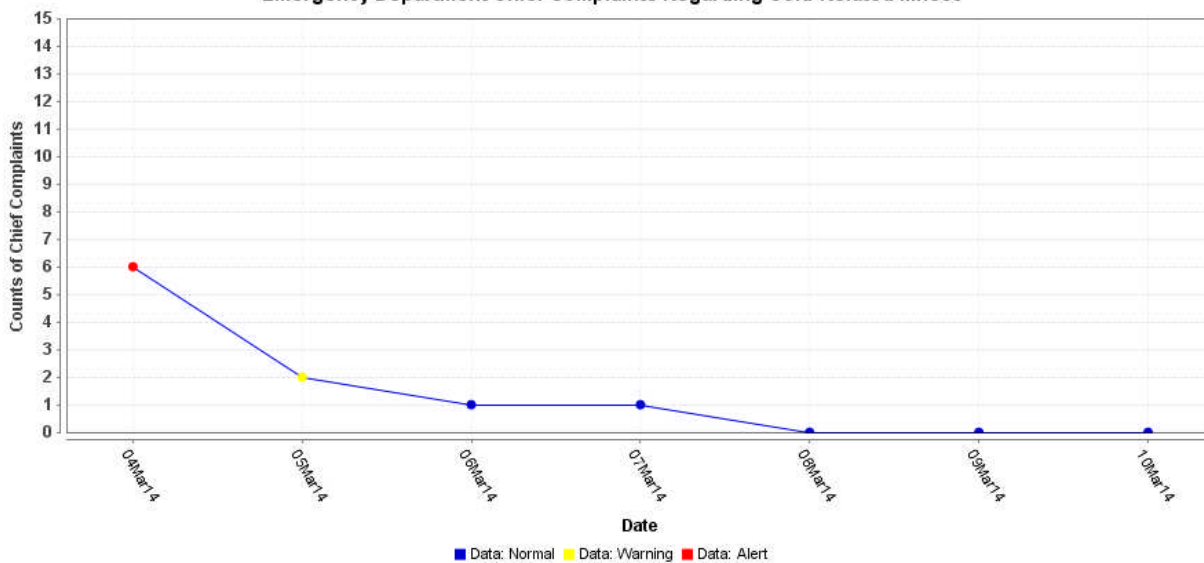
This is the final weekly cold report for the 2013-2014 season. A summary report for the entire season will be available in two weeks.

National Weather Service Forecast: No extreme cold forecast.

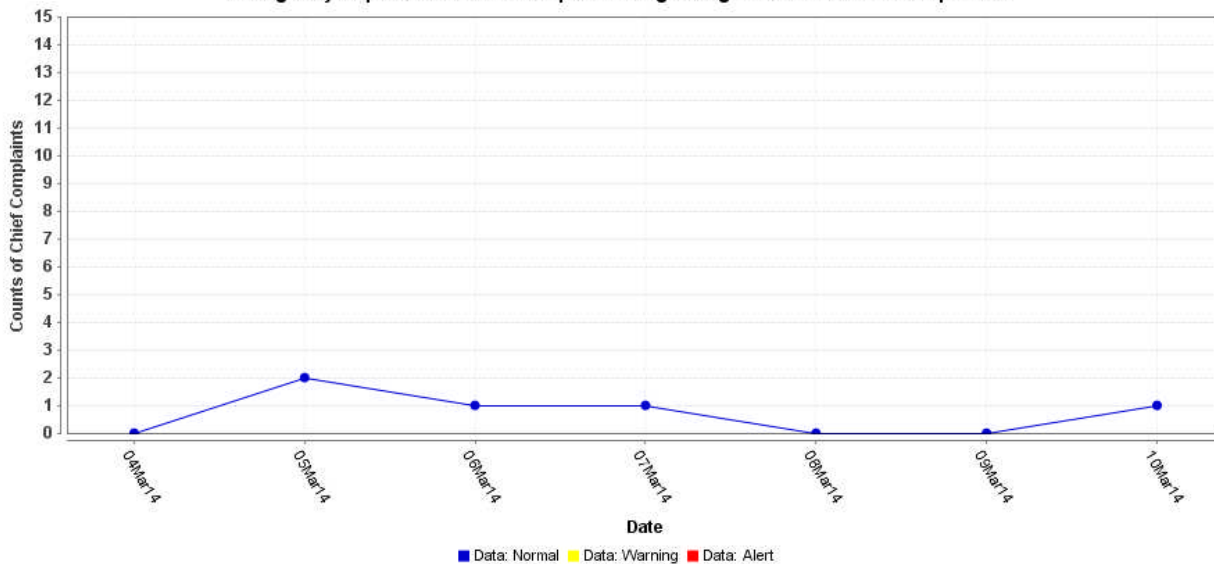


Note: Wind Chill is only calculated for temperatures below 50°F and wind speeds above 3 mph

Emergency Department Chief Complaints Regarding Carbon Monoxide Exposure

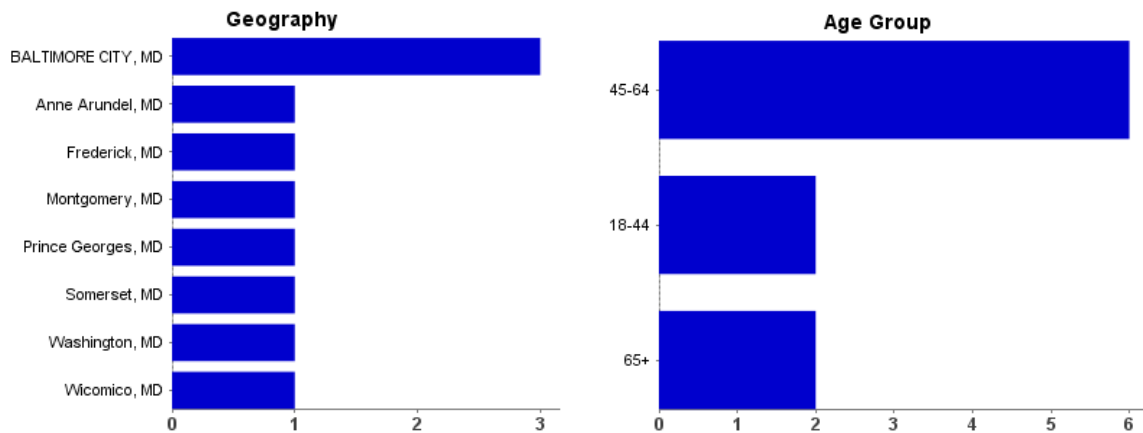
