1) Delete - 3.10.3 Number of Personnel to Propose

As part of the Proposal evaluation, Offerors shall propose exactly 10 personnel who are expected to be available as of the start date specified in the Notice to Proceed (NTP Date). Offerors shall describe in a Staffing Plan how additional resources shall be acquired to meet the needs of the Department. Offerors may generally describe planned positions in a Staffing Plan. Such planned positions may not be used as evidence of fulfilling personnel minimum qualifications.

Add 3.10.3 Number of Personnel to Propose

- 3.10.3.1 As part of the Proposal evaluation, Offerors shall propose exactly 11 personnel with the experience and qualifications required as identified in **Appendix 7 Key Personnel** of this RFP who are expected to be available as of the start date specified in the Notice to Proceed (NTP Date).
- 3.10.3.2 Offerors are encouraged to provide personnel estimates according to established standards that will be sufficient to successfully deliver the solution based on the scope of work determined. Offerors shall describe in a Staffing Plan how additional resources shall be acquired to meet the needs of the Department. Offerors may generally describe planned positions in a Staffing Plan. Such planned positions may not be used as evidence of fulfilling personnel minimum qualifications.
