A. Minutes

B. Announcements

Executive Director - The list of registrants for the October law exam was reviewed. A motion was made, seconded, and unanimously carried to approve the list and others who may register later.

Ms. Smith reported that she attended a meeting with representatives from the company Talkspace. Talkspace provides online and mobile therapy services. Communication is asynchronous. The Board received a letter from Talkspace emphasizing the importance of recognizing texting and other nontraditional means of providing psychological services. Currently these modes of delivering services are exempt from the Board's telepsychology

regulations. The Executive Directors of the Board of Professional Counselors and the Board of Social Work also attended the meeting. Ms. Smith will provide additional information as it becomes available.

Dr. Gormally and Mr. Razdan agreed to present information on the telepsychology regulations at the Maryland Psychological Association's meeting on November 1st.

The Board's retreat will be held on December 6, 2019 at Turf Valley Resort. Members will review some frequently referenced regulations such as child custody regulations and supervision of registered psychology associates.

Ms. Smith reported that the office is in the process of pursuing an online application system. Additional information will be forthcoming. Ms. Smith also reported that the criminal history records check will commence with renewals in 2021. The 2021 licensees will be notified during the summer of 2020.

Dr. Bishop announced that Mr. Zeno St. Cyr II will receive the Dr. Benjamin Shimberg Public Service Award recognized by the Citizen Advocacy Center in Washington, DC. Mr. St. Cyr will receive the award in December.
