A farmer's market is where a person offers or sells one or more of the following food products directly to the public

- Raw agricultural products;
- Foods that are non-potentially hazardous, do not require refrigeration and are processed in a licensed food processing plant and operated according to COMAR 10.15.04.19;
- Cottage Foods produced in accordance with COMAR 10.15.03.27;
- Eggs offered in compliance with Maryland Department of Agriculture regulations;
- Commercially processed non-potentially hazardous pre-packaged and bottle products

Participants who vend the products listed above will not require a food service permit from the Queen Anne's County Health Department, unless they intend to sample their products at the market.

Other food service offerings, such as coffee beverage service, hot prepared foods, ready-to-eat food items, or other potentially hazardous foods would require a Temporary Food Service Facility permit prior to participation in a market.

All food products must be prepackaged and labeled.</li> <li>• If licensed as a food service facility outside of Queen Anne's County, please provide a copy of your current license.</li> <li>• All food items must be protected from possible contamination, stored off the ground and prepackaged (unless sampling).</li> </ul>
