Approval of the Agenda

Credentials Committee Update

During the April 11, 2023 Ad Hoc Credentials Committee Meeting, the Committee voted to approve the following:

Financial Disclosures – Due by April 30, 2023

Ms. Lee reminded Board Members that their Board Members' 2022 Financial Disclosure (Form 2) are due by April 30, 2023. Board Members must submit the form at https://efds.ethics.maryland.gov and must contact the Ethics Commission Office at 410-260-7770 if assistance is needed. Ms. Lee will send another reminder to Board Members via email as soon as possible.

Designation Authorization Memorandum

Ms. Lee provided a memorandum addendum to COMAR 10.33.01.05A, which indicates that Board Chair Friedman is designating Ms. Lee to be the signer of official documents of the Board (AIT Program Approval Letters, AIT Program Resumption Approval Letters, License Verification Letters and Forms, and Preceptor Certifications).

New Online OHCQ License Notifications

On April 10, 2023, Ms. Heather Reed contacted Ms. Lee to discuss OHCQ's plans to implement a new, online process for LNHA to submit license change notifications. During the Board Meeting, Ms. Reed also provided a brief description of OHCQ's proposed change notification process and will keep the Board updated.

Legislative Updates

Ms. Patricia Cash, Legislative Committee Chair, provided an overview and status of the legislative bills that were relevant to BLTCA. The information was provided from the 2023 End of Session Report, drafted by Lillian Reese, Legislative and Regulation Coordinator.

- HB 196 Health Occupations Service Members, Veterans, and Military Spouses Temporary Licensure, Certification, Registration, and Permitting STATUS: Did not get voted out of the House HGO Committee.
- *HB 214/SB 281 Commission on Public Health Establishment* STATUS: The HB passed with amendments. The SB did not get voted out of the Senate Finance Committee. To be effective 10/1/23.
- HB 454/SB 187 Health Occupations Licenses, Certificates, and Registrations Lawful Presence and Identification Numbers STATUS: The HB and SB passed with amendments. To be effective 10/1/23.
- HB 774/SB 665 Assisted Living Programs Unlicensed Programs Resident Abuse, Exploitation, and Neglect (The Senator Delores Kelley Residents of Unlicensed Programs Protection Act) STATUS: The HB and SB passed with amendments. To be effective 10/1/23.

- HB 786/SB 648 Electronic Health Networks and Electronic Medical Records Nursing Homes Release of Records STATUS: The SB passed with amendments. The HB passed, but did not get voted out of the Senate. To be effective 7/1/23.
- HB 906 Occupational Licensing and Certification Criminal History Prohibited Disclosures and Predetermination Review Process STATUS: The HB did not get voted out of the House HGO Committee.
- SB 78 Health Occupations Service Members, Veterans, and Military Spouses Temporary Licensure, Certification, Registration, and Permitting STATUS: Did not get voted out of the Senate Finance Committee.

Move to Closed Session

A motion was made to move to Closed Session. It was seconded and carried.

Closed Session Statement
