

## Provider LTSSMaryland Go-Live Dates for Personal Supports

Under the 21st Century Cures Act, passed by the United States Congress, all states must implement an Electronic Visit Verification (EVV) system for all home-based personal care services no later than January 1, 2021. Under the DDA service array, this includes Personal Supports and Personal Supports Enhanced.

## **DDA's Implementation Plan for EVV**

The DDA will be implementing EVV by Region, starting with the Eastern and Western Regions on October 1, 2020. Providers who support people in Personal Supports services in multiple regions, will transition to EVV at the latest date for the regions in which they operate. For example, an agency that provides Personal Supports in the Eastern Shore and Central Regions would begin using EVV on December 1, 2020 for everyone they support.

## What is Electronic Visit Verification?

- **Electronic Visit Verification (EVV)** refers to technology that electronically verifies that services are delivered at the right time, in the right place and to the right person.
- The **Federal 21st Century CURES Act** requires that Maryland uses Electronic Visit Verification (EVV) to verify six factors for Personal Supports services:
  - Type of service performed
  - Person receiving the service
  - o Date of the service
  - o Location of the service
  - o Individual providing the service
  - Time the service begins and ends
- Maryland's EVV system is called ISAS (In-Home Supports Assurance System)
- Personal Supports & Personal Supports Enhanced Services will require the use of EVV via Maryland's ISAS system.

\*Individuals self-directing services will still participate in EVV, but will not use the same process. Details of how individuals participating in Self-Directed Services will use EVV will be provided soon.
