

Home and Community-Based Services Medicaid 1915(c) Waivers

- States may cover long term services and supports (LTSS) under the Medicaid State Plan and under home and community-based services (HCBS) waivers.
- Under a Medicaid waiver, a state can waive certain Medicaid program requirements.

Home and Community-Based Services Medicaid 1915(c) Waivers

- States may provide care for people who might not be eligible under Medicaid in the community, but who would be covered by Medicaid if they were in an institution.
- States may cover services not otherwise able to be covered under the Medicaid State Plan.
- States may limit the number of waiver participants.

Home and Community-Based Services Medicaid 1915(c) Waivers

All HCBS 1915(c) waiver programs:

- Are authorized under Section 1915(c) of the Social Security Act.
- · Are fee-for-service programs.
- Require individuals to meet criteria that are set by the state within certain limits that are established by federal statute and regulations.
- Waiver enrollees receive full Medicaid benefits and may receive all State Plan services for which they qualify.

1915(c) HCBS Waiver Program Basics

States can waive certain Medicaid program requirements under HCBS waivers, including:

- Statewideness* (Section 1902(a)(1))
 - Lets states target waivers to areas of the state where the need is greatest or where certain types of providers are available.

*All of Maryland's current 1915(c) waivers are statewide

1915(c) HCBS Waiver Program Basics

States can waive certain Medicaid program requirements under HCBS waivers, including:

- Comparability of services* (Section 1902(a)(10)(B))
 - Lets states make waiver services available only to certain groups of people who are at risk of institutionalization (e.g., elderly and disabled, technology-dependent children, individuals with developmental or intellectual disabilities).

*Applicable to all of Maryland 1915(c) waivers



1915(c) HCBS Waiver Program Basics

States can waive certain Medicaid program requirements under HCBS waivers, including:

- Community income and resource rules* (Section 1902(a)(10)(C)(i)(III))
 - Lets states provide Medicaid to people who would otherwise be eligible only in an institution.
 - The monthly income of an individual may not exceed 300% of Supplemental Security Income (SSI) benefits, and the countable assets may not exceed \$2,000 (or \$2,500 depending on the individual's eligibility category).

*Applicable to all of Maryland 1915(c) waivers, except Medical Day Care.



1915(c) HCBS Waiver Program Basics

Waiver programs must:

- Demonstrate that providing waiver services will not cost more than providing services in an institution (i.e., be cost neutral).
- Ensure the protection of the participants' health and welfare.

1915(c) HCBS Waiver Program Basics

Waiver programs must:

- Provide adequate and reasonable provider standards to meet the needs of the target population(s).
- Ensure that services follow an individualized and person-centered plan of care.

1915(c) HCBS Waiver Participation

Individuals participating in waiver programs must:

- · Meet financial eligibility
 - · Based on income and assets.
- · Meet medical eligibility
 - Based on program (e.g., nursing facility level of care, chronic hospital level of care, or intermediate care facility for individuals with intellectual disabilities).
- · Meet technical eligibility
 - Based on program (e.g., age requirements, diagnosis, or have a plan that meets the individual's health and safety needs).



1915(c) HCBS Waiver Participation

Individuals participating in waiver programs have access to Medicaid State Plan services, for example:

Community First Choice program services, such as personal assistance.

Maryland's Medicaid HCBS Waivers

Maryland offers eight 1915(c) waivers:

- · Community Pathways Waiver (1984)
 - Requires Intermediate Care Facility for Individuals with Intellectual Disabilities (ICF/IID) level of care (LOC)
- Model Waiver (1985)
 - Requires chronic hospital/special pediatric hospital or nursing facility (NF) LOC
- · Autism Waiver (2001)
 - Requires ICF/IID LOC
- · Brain Injury Waiver (2003)
 - · Requires chronic hospital or NF LOC

Maryland's Medicaid HCBS Waivers

Maryland offers eight 1915(c) waivers:

- Medical Day Care Waiver (2008)
 - · Requires NF LOC
- Community Options Waiver (2014)
 (formerly Older Adults Waiver and Living at Home Waiver, consolidated January 2014)
 - Requires NF LOC
- Family Supports Waiver (2018)
 - Requires ICF/IID LOC
- · Community Supports Waiver (2018)
 - · Requires ICF/IID LOC

Waiver Submissions

- States must assure the Centers for Medicare and Medicaid Services (CMS) that its waiver programs are cost neutral.
 - States submit an annual financial report to CMS to demonstrate that its waiver programs meet cost-neutrality requirements, as detailed in each waiver application.
- Waivers must be renewed every five years after initial approval.
